 Resolution marking the 110th anniversary of the Armenian Genocide and declaring April 24, 2025, as "Armenian Genocide Commemoration Day" in the City and County of

[Armenian Genocide Commemoration Day - April 24, 2025]

WHEREAS, The Armenian people, living in their historic homeland for thousands of years, were subjected to severe persecution by the Turkish government of the Ottoman Empire before and after the turn of the twentieth century, including widespread massacres, usurpation of land and property, and destruction of cultural institutions and monuments during the period from 1894 to 1896, and again in 1909; and

WHEREAS, The unspeakable horrors experienced by the Armenian people at the hands of the Ottoman Turkish government culminated in 1915 in what is now known as the Armenian Genocide; and

WHEREAS, Between 1915 and 1923, the Turkish authorities planned and implemented genocide against the Armenians, one of the world's oldest civilizations living in its indigenous homeland of more than 3,500 years, resulting in the murder of 1.5 million Armenian women, men and children, more than half of the Armenian population living on their ancient homeland, as well as the expropriation or destruction of all their personal and community properties; and

WHEREAS, The U.S. House of Representatives adopted House Resolution No. 296 (Schiff) on October 29, 2019, which states it is U.S. policy to commemorate the Armenian Genocide and the US Senate passed Senate Resolution No. 150 (Menendez) on December 12, 2019, which formally recognizes and affirms the historical facts of the Armenian Genocide on behalf of the U.S. government and calls for broader education on this heinous crime and its impact on generations of Armenians; and

WHEREAS, On April 24, 2021, President Joseph Biden became the first U.S. President to formally recognize the massacres of Armenians as genocide; and

WHEREAS, Despite the unequivocal acknowledgement of this crime as genocide, Turkey and Azerbaijan continue to deny that it took place; and

WHEREAS, The legacy of the Armenian Genocide and the consequences of its denial are seen to this day in the ongoing policy of violence and discrimination Armenians face at the hands of the governments of Turkey and Azerbaijan; and

WHEREAS, This policy of aggression culminated in the assault on the Armenian region of Artsakh, also known as Nagorno-Karabakh, by Azerbaijan with Turkey's support in 2020, followed by a 10-month blockade depriving the remaining Armenian population of vital supplies; and

WHEREAS, Since September 23, 2023, the Government of Azerbaijan has fully occupied and ethnically cleansed Artsakh of its Armenian population, uprooting 120,000 Armenians from their homelands, with no clear intention to allow their return on the part of the Azerbaijani Government, and destroying Artsakh's Armenian cultural heritage sites; and

WHEREAS, On February 7, 2023, the Board of Supervisors adopted Resolution No. 052-23, condemning Azerbaijan's Blockade of the Armenians of Nagorno-Karabakh (Artsakh) and ongoing human rights violations, which is hereby declared to be a part of this Resolution as if set forth fully herein; and

WHEREAS, In the wake of the war, Azerbaijani and Turkish leaders publicly praised the perpetrators of the Armenian Genocide, and proliferated rhetoric aimed at dehumanizing the Armenian people, destroyed Artsakh's Armenian cultural heritage sites, and continued the imprisonment and torture of Armenian prisoners of war; and

WHEREAS, The Government of Azerbaijan has occupied Armenia's internationally recognized territories since September 2022; and

WHEREAS, The Azerbaijani ethnic cleansing of Nagorno-Karabakh has uprooted 120,000 Armenians from their homelands, with no clear intention to allow their return on the part of the Azerbaijani Government; and

WHEREAS, April 24, 2025 marks the 110th anniversary of the beginning of the Armenian Genocide; and

WHEREAS, Denial is among the surest indicators of further genocidal massacres; and the continued denial of the Armenian Genocide by successive governments of Turkey and Azerbaijan and the lack of accountability and reparations for those crimes has added to the injury and losses suffered by the genocide victims and their descendants, created an atmosphere of intimidation and mistrust among neighboring states, enabled and emboldened further acts of genocide and ethnic cleansing against the Armenian people, and sent a message to the international community that genocide can be carried out without punishment; now, therefore, be it

RESOLVED, That the San Francisco Board of Supervisors hereby designates April 24, 2025, as "Armenian Genocide Commemoration Day" in the City and County of San Francisco, marking the 110th anniversary of the Armenian Genocide; and, be it

FURTHER RESOLVED, That the San Francisco Board of Supervisors urges the San Francisco School District and San Francisco Board of Education to support public education of the Armenian Genocide and its long-term repercussions, so as to ensure the lessons of history are not forgotten, its influence on current events are understood, and so that students will recognize their role in effecting positive global change; and, be it

FURTHER RESOLVED, That the San Francisco Board of Supervisors expresses its condemnation of genocide denial in all its forms, noting that the prevention of atrocities must begin with holding perpetrators to account; and, be it

FURTHER RESOLVED, That the San Francisco Board of Supervisors reaffirms its support for the Armenians of Artsakh and reaffirms its support for efforts to hold Azerbaijan accountable for its ongoing occupation of the region.

FURTHER RESOLVED, That the San Francisco Board of Supervisors directs the Clerk of the Board to transmit copies to members of the San Francisco Board of Education and United States Senator Alex Padilla, Senator Adam Schiff, Speaker Emerita Nancy Pelosi, and United States Representative Kevin Mullin.
