10 WHEREAS, Sayed Jalal Heydari is seeking the issuance of a Type 20 off-sale
11 beer and wine license for Alimento Deli, located at 507 Columbus Avenue; and,

12 WHEREAS, The Planning Department has verified that the area is properly
13 zoned and recommends approval; and,

14 WHEREAS, The Police Department has filed zero (0) protests with the
15 Department of Alcoholic Beverage Control under California Business and Professions
16 Code, Section 24013, and recommends that the Department of Alcoholic Beverage
17 Control issue the liquor license with conditions; now, therefore, be it

18 RESOLVED, That in accordance with California Business and Professions Code,
19 Section 23958.4, the San Francisco Board of Supervisors hereby determines that the
20 issuance of a Type 20 off-sale beer and wine license to 507 Columbus Avenue (District
21 3), to Sayed Jalal Heydari for Alimento Deli, will serve the public convenience or
22 necessity of the City and County of San Francisco; and, be it

23 FURTHER RESOLVED, That the Board of Supervisors hereby endorses and
24 adopts the recommendations of the Police Department and recommends that the
25 Department of Alcoholic Beverage Control issue the license with conditions.


