17 Nicholas Belloni, seat 3, succeeding himself, term expired, must be nominated by the  
18 District 4 Supervisor from the organizations listed in Resolution No. 391-13, for the unexpired  
19 portion of a two-year term ending February 1, 2016.

20 Les Hilger, seat 13, succeeding himself, term expired, must be nominated by the  
21 District 1 Supervisor from the organizations listed in Resolution No. 391-13, for the expired  
22 portion of a two-year term ending February 1, 2016.
