3 **Resolution approving the pedicab fare schedule for Cabrio Taxi.**

5 WHEREAS, Abraham Pedicabs LLC, dba Cabrio Taxi ("Cabrio Taxi") is a State of  
6 California Limited Liability Corporation that operates pedicabs in San Francisco; and,

7 WHEREAS, Cabrio Taxi was issued License Number 14971 by the Port of San  
8 Francisco on May, 1 2011 to operate on its property; and,

9 WHEREAS, Section 39.09 of the Police Code states that permittees issued pedicab  
10 permits pursuant to the provisions of Article 39 shall file with the Board of Supervisors the  
11 fares per passenger charged for each trip; and,

12 WHEREAS, Section 39.09 further states that the Board of Supervisors may adopt,  
13 modify or reject the fare schedules submitted; and,

14 WHEREAS, Cabrio Taxi has filed a fare schedule with the Board of Supervisors, as  
15 required under Section 39.09 of the Police Code; and,

16 WHEREAS, Cabrio Taxi's proposed fare schedule, for two passengers, is the following:  
17 \$20.00 for the Ferry Building to/from Townsend, \$20.00 for Pier 39 to/from the Ferry Building,  
18 \$20.00 for Pier 39 to/from Ghirardelli Square, \$40.00 for Pier 39 to/from Townsend Street,  
19 \$40.00 for the Ferry Building to/from Ghirardelli Square, \$60.00 for the Townsend to/from  
20 Ghirardelli Square, \$95 per hour for a leisurely tour, and \$8 per person more for all fares for  
21 more than two passengers; now, therefore be it

22 RESOLVED, that pursuant to Section 39.09 of the Police Code, the Board of  
23 Supervisors approves the fare schedule proposed by Cabrio Taxi.
