

1 [Liquor License - 1148-1150 Mission Street - City Beer Store]

3 **Resolution determining that the premise-to-premise transfer of a Type-42 on-sale**
4 **beer and wine public premises liquor license to City Beer Store, LLC, located**
5 **at 1148-1150 Mission Street (District 6), will serve the public convenience or**
6 **necessity of the City and County of San Francisco, in accordance with California**
7 **Business and Professions Code, Section 23958.4; and recommending that the**
8 **California Department of Alcoholic Beverage Control impose conditions on the**
9 **issuance of the license.**

11 WHEREAS, City Beer Store, LLC, doing business as City Beer Store located
12 at 1148-1150 Mission Street (District 6), is seeking the premise-to-premise transfer of a
13 Type-42 on-sale beer and wine public premises liquor license; and

14 WHEREAS, The Planning Department has verified that the area is properly
15 zoned and recommends approval; and

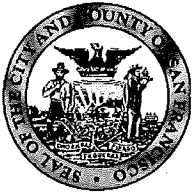
16 WHEREAS, The Police Department has filed zero (0) protests and zero (0)
17 letters of support with the Department of Alcoholic Beverage Control under California
18 Business and Professions Code, Section 24013, and recommends that the Department
19 of Alcoholic Beverage Control issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department are the
21 following: 1) sales, service, and consumption of alcoholic beverages shall be permitted
22 between the hours of 10:00 a.m. and 12:00 a.m. Sundays through Wednesdays,
23 and 10:00 a.m. through 2:00 a.m. Thursdays through Saturdays; 2) no noise shall be
24 audible at any nearby residences; 3) petitioner(s) shall actively monitor the area under
25 their control in an effort to prevent the loitering of persons on any property adjacent to

1 the licensed premises as depicted on ABC-253; 4) sales, service, and consumption of
2 alcoholic beverages shall be permitted in or on the patio area only between the hours
3 of 10:00 a.m. and 10:00 p.m. each day of the week; 5) sales and service of alcoholic
4 beverages on said patio area shall be restricted to waiter/waitress service and only to
5 patrons seated at a table; and 6) when the said outdoor patio area of the premises is
6 being utilized for the sales, service, and consumption of alcoholic beverages, a premise
7 employee shall be in attendance and maintain continuous supervision at all times of
8 said area; now, therefore, be it

9 RESOLVED, That in accordance with California Business and Professions Code,
10 Section 23958.4, the Board of Supervisors of the City and County of San Francisco
11 hereby determines that the premise-to-premise transfer of a Type-42 on-sale beer and
12 wine public premises liquor license to City Beer Store, LLC, located at 1148-1150
13 Mission Street (District 6), will serve the public convenience or necessity of the City and
14 County of San Francisco; and, be it

15 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
16 San Francisco hereby endorses and adopts the recommendations of the Police
17 Department listed above and recommends that the Department of Alcoholic Beverage
18 Control issue the license with those conditions.
