3 **Ordinance authorizing settlement of the lawsuit filed by Ike Ohannesyan against the**  
4 **City and County of San Francisco for \$50,000; the lawsuit was filed on May 17, 2021, in**  
5 **San Francisco Superior Court, Case No. CGC-21-591955; entitled Ike Ohannesyan v.**  
6 **Johnathon Ng, et al.; the lawsuit involves an alleged personal injury arising from an**  
7 **accident involving a police car.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Ike Ohannesyan v. Johnathon Ng, et  
12 al., San Francisco Superior Court, Case No. CGC-21-591955, by the payment of \$50,000.  
13 The lawsuit involves an alleged personal injury arising from an accident involving a police car.

14 Section 2. The above-named action was filed in San Francisco Superior Court on May  
15 17, 2021, and the following parties were named in the lawsuit: Ike Ohannesyan, plaintiff,  
16 Johnathon Ng #282 and City and County of San Francisco, defendants.
