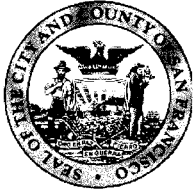
WHEREAS, The Planning Department has verified that the area is properly zoned and recommends approval; and

WHEREAS, The Police Department has filed zero protests and zero letters of support with the Department of Alcoholic Beverage Control under California Business and Professions Code, Section 24013, and recommends that the Department of Alcoholic Beverage Control issue the liquor license with conditions; and

WHEREAS, The conditions recommended by the Police Department are the following: 1) Petitioner(s) shall actively monitor the area under their control in an effort to prevent the loitering of persons on any property adjacent to the licensed premises as depicted on the ABC-257; now, therefore, be it

1           RESOLVED, That in accordance with California Business and Professions Code,  
2 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
3 hereby determines that the person-to-person, premise-to-premise transfer of a Type-21  
4 off-sale general beer, wine, and distilled spirits liquor license to Barbary Coast  
5 Merchants LLC, doing business as Amador Liquors and Wines, located at 550  
6 Montgomery Street, will serve the public convenience or necessity of the City and  
7 County of San Francisco; and, be it
