1 [Amending the Articles of Formation of the South of Market Project Area Committee to 2 Require new elections.] 3 Resolution amending the Articles of Formation of the South of Market Project Area 4 Committee to (1) require new elections and (2) add a representative who shall be a 5 parent of a student of the Bessie-Carmichael School as a category of membership 6 7 thereof following the adoption of the Redevelopment Plan Amendment for the South of 8 Market Redevelopment Project Area. 9 WHEREAS, On ______, 2005, the Board of Supervisors adopted Ordinance 10 No. _____ approving and adopting the Redevelopment Plan Amendment for the South 11 12 of Market Redevelopment Project Area (the "Redevelopment Plan Amendment") following a 13 duly noticed public hearing to consider the adoption of such Redevelopment Plan Amendment in accordance with the requirements of the Community Redevelopment Law (Sections 33000 14 et seg. of the Health and Safety Code, and hereafter referred to as the "Redevelopment 15 Law"). Prior notice of such hearing was published in the San Francisco Chronicle, a 16 17 newspaper of general circulation, in accordance with Section 33361 of the California Health 18 and Safety Code, describing the boundaries of the proposed Project Area and stating the day, 19 hour and place when and where any interested persons may appear before the Board of 20 Supervisors to object to the proposed Redevelopment Plan Amendment. At such hearing the 21 Board of Supervisors considered the report and recommendations of the Agency and the 22 Planning Commission, the Final Environmental Impact Report for the South of Market 23 Redevelopment Plan ("FEIR"), the Final Supplement to such FEIR, and all evidence and testimony for and against the proposed Redevelopment Plan Amendment. 3	WHEREAS, Prior to the adoption of the Redevelopment Plan Amendment, by		
4	Resolution No. 268-97 adopted on March 24, 1997, the Board of Supervisors (i) determ	nined	
5	that a project area committee shall be formed for the South of Market Project Area, and	(ii) t	
6	approved and adopted the Articles of Formation of a Project Area Committee for the So	outh of	
7	Market Project (the "Articles of Formation"); and,		
8	WHEREAS, By Resolution No. 575-97, adopted on June 9, 1997, the Board of		
9	Supervisors confirmed the election of the members of the South of Market Project Area	ì	
10	Committee ("SOMPAC"); and,		
11	WHEREAS, The Articles of Formation provide that the Board of Supervisors ma	у	
12	amend such Articles of Formation by resolution after a public hearing pursuant to the		
13	Redevelopment Law; and,		
14	WHEREAS, Section 33385(b) requires that notices of all meetings and hearings	of the	
15	Redevelopment Agency or the Board of Supervisors relative to the formation and select	tion of	
16	a project area committee be done in the same manner as specified in Section 65090(a) of the	
17	Government Code, which requires a written notice to be published in a newspaper of g	eneral	
18	circulation at least ten (10) days prior to the date of the hearing; and,		
19	WHEREAS, The Board of Supervisors wish to amend the Articles of Formation	o (1)	
20	require a new election of the members of and (2) add a representative who shall be a p	arent	
21	of a student of the Bessie-Carmichael School as a category of membership to the SON	1PAC	
22	as set forth in the Amended and Restated Articles of Formation on file with the Clerk of	the	
23	Board of Supervisors in File No, which is hereby declared to be a part of this		
24	resolution as if set forth fully herein; and,

1	WHEREAS, On, 2005, notice of public hearing was published in the San
2	Francisco Chronicle, a newspaper of general circulation, stating the day, hour and place of
3	this Board of Supervisors' meeting when and where any interested persons may appear
4	before the Board of Supervisors to object or comment upon the proposed Amendment to the
5	Articles of Formation; and,
6	WHEREAS, The purpose of the additional representative is to provide representation
7	for the users of the Bessie-Carmichael School which was added to the South of Market
8	Redevelopment Project Area by the recent amendment to the South of Market
9	Redevelopment Plan; and,
10	WHEREAS, The purpose of such new election is to elect new members to the
11	SOMPAC and affirm the SOMPAC as the body that the Redevelopment Agency must consult
12	with and obtain the advice of concerning those policy matters which deal with the planning
13	and provision of residential facilities or replacement housing and other matters that affect the
14	residents of the South of Market Redevelopment Project Area; now, therefore, be it
15	RESOLVED, That the Board of Supervisors hereby determines that (1) an additional
16	representative shall be added to SOMPAC consisting of a parent of a student of the Bessie-
17	Carmichael School and (2) a new election shall be held for the SOMPAC to consult with the
18	Redevelopment Agency concerning those policy matters which deal with the planning and
19	provision of residential facilities or replacement housing and other matters that affect the
20	residents of the South of Market Redevelopment Project Area as set forth in Section 33386 of
21	the Health and Safety Code; and,
22	FURTHER RESOLVED, That the Board of Supervisors hereby adopts the Amended
23	and Restated Articles of Formation on file with the Clerk of the Board of Supervisors in File

1	No, calling for a new election of the members of the SOMPAC within days
2	following the effective date this Resolution; and, be it
3	FURTHER RESOLVED, That the new election shall be conducted in accordance with
4	the "Procedures for the Election of Members to Redevelopment Project Area Committees in
5	the City and County of San Francisco" approved and adopted by Board of Supervisors
6	Resolution No. 1087-96 on November 25, 1996, a copy of which is on file with the Clerk of the
7	Board of Supervisors in File No; and, be it
8	FURTHER RESOLVED, That nothing in this Resolution is intended to invalidate any of
9	the actions or recommendations made by the SOMPAC in connection with the adoption of the
10	Redevelopment Plan Amendment, and the call for a new election of members of the
11	SOMPAC is only for the purpose of affirming the SOMPAC members who will be consulting
12	with the Redevelopment Agency in connection with the implementation of the Redevelopment
13	Plan Amendment as set forth in Section 33386 of the Health and Safety Code; and, be it
14	FURTHER RESOLVED, That the Redevelopment Agency of the City and County of
15	San Francisco is hereby authorized and directed to take all steps necessary and appropriate
16	to implement the new election of the members of the SOMPAC in accordance with the
17	Amended and Restated Articles of Formation.
