Ordinance authorizing settlement of the lawsuit filed by Sean Wendell Moore against the City and County of San Francisco for \$3,250,000; the lawsuit was filed on January 29, 2018, in United States District Court for the Northern District of California, Case No. 3:18-cv-00634-SI; entitled Sean Moore v. City and County of San Francisco, et al.; the lawsuit involves claims of civil rights violations and use of excessive force.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Sean Moore v. City and County of San Francisco, et al., United States District Court for the Northern District of California, Case No. 3:18-cv-00634-SI by the payment of \$3,250,000. The lawsuit involves claims of civil rights violations and use of excessive force.

Section 2. The above-named action was filed in United States District Court for the Northern District of California on January 29, 2018, and the following parties were named in the lawsuit: plaintiff: Sean Moore; defendants: City and County of San Francisco, Kenneth Cha, Colin Patino.
