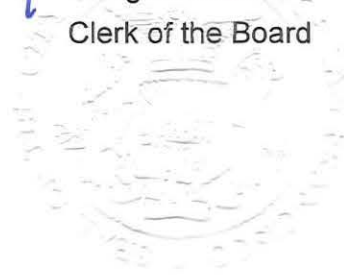

16 known as Covered California, to facilitate the purchase of qualified health plans by qualified
17 individuals and qualified small employers; and

18 WHEREAS, While PPACA has brought many improvements in health care and health
19 care coverage, it still leaves many Californians without coverage or with inadequate coverage;
20 and

21 WHEREAS, The 45th President of the United States, Donald Trump, signed an
22 executive order on his first day in office giving federal agencies broad powers to dismantle
23 regulations created under the PPACA; and

24 WHEREAS, The Executive Order explicitly asserted that the Trump Administration's
25 official policy is "to seek the prompt repeal" of the PPACA which, if effected, could result in the

1 loss of \$18 billion in federal funding for the expanded Medi-Cal program and \$5.4 billion in
2 premium subsidies and cost-sharing reductions for Covered California, endangering the
3 exchange's survival, according to a report issued by the California State Legislative Analyst's
4 Office; and

5 WHEREAS, Californians, as individuals, employers, and taxpayers have also
6 experienced a rise in the cost of health care and health care coverage in recent years,
7 including rising premiums, deductibles, and copays, as well as restricted provider networks
8 and high out-of-network charges; and

9 WHEREAS, To address the threats to the PPACA and the ensuing fiscal crisis facing
10 the health care system and the state, and to ensure Californians can maintain their access to
11 health care, comprehensive health care coverage needs to be provided; and

12 WHEREAS, Senate Bill 562 ("SB 562"), known as the Californians for a Healthy
13 California Act, is currently being considered by the California State Legislature, and would
14 establish a comprehensive universal single-payer health care coverage program and a health
15 care cost control system for the benefit of all residents of the state; now, therefore, be it

16 RESOLVED, That the San Francisco Board of Supervisors urges the California State
17 Legislature to support SB 562, such that Californians can be assured of access to affordable
18 and comprehensive health care necessary for a healthy and prosperous state; and, be it

19 FURTHER RESOLVED, That the Clerk of the Board of Supervisors is hereby directed
20 to forward this resolution to the Speaker of the Assembly and President Pro Tem of the
21 Senate of the California State Legislature.
