4 **the City and County of San Francisco for \$95,000; the lawsuit was filed on August 17,**
5 **2022, in San Francisco Superior Court, Case No. CGC-22-601310; entitled Maria Elena**
6 **Rosales v. City and County of San Francisco; the lawsuit involves alleged personal**
7 **injury on a City street.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Maria Elena Rosales v. City and
12 County of San Francisco, San Francisco Superior Court, Case No. CGC-22-601310 by the
13 payment of \$95,000. The lawsuit involves alleged personal injury on a City street.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 August 17, 2022, and the following parties were named in the lawsuit: Plaintiff Maria Elena
16 Rosales, Defendant City and County of San Francisco.
