3 **Motion directing the Budget and Legislative Analyst to conduct a review of the**  
4 **City's revenues and expenditures associated with hosting events related to**  
5 **Super Bowl 50.**

7 WHEREAS, On August 9, 2012, the San Francisco Bay Area Super Bowl 50  
8 Host Committee submitted a bid to compete to host Super Bowl 50; and

9 WHEREAS, On May 21, 2013, the National Football League announced that  
10 Super Bowl 50 would take place in Santa Clara, California on February 7, 2016; and

11 WHEREAS, San Francisco will host a number of Super Bowl-related events  
12 including the "Super Bowl City", which will take place at Justin Herman Plaza between  
13 January 30 and February 7, 2016; and

14 WHEREAS, The City has undertaken extensive preparations for both the public  
15 and private Super Bowl events; and

16 WHEREAS, A number of City departments are anticipated to be involved in work  
17 related to the Super Bowl, including the Department of Emergency Management, the  
18 Department of Public Works, the Office of Economic and Workforce Development, the  
19 Port of San Francisco, the San Francisco Municipal Transportation Agency, the San  
20 Francisco Fire Department, and the San Francisco Police Department; and

21 WHEREAS, On December 7, 2015, the Board of Supervisors Land Use and  
22 Transportation Committee held a hearing on the anticipated impacts to the City from  
23 Super Bowl-related events; and

24 WHEREAS, Heretofore the planning, negotiation, and mobilization of resources  
25 in preparation for the Super Bowl-related events have been performed entirely by City

1 departments without official Board of Supervisors oversight or exercise of authority  
2 despite the expenditure of what are expected to be significant resources; now,  
3 therefore, be it

4           MOVED, That the Budget and Legislative Analyst is hereby directed to conduct  
5 a review of the City's revenues, expenditures, staffing plans, and service disruptions  
6 associated with hosting events related to Super Bowl 50.


