2	
3	Resolution recognizing and celebrating every May as Asian Pacific American Heritage
4	Month in the City and County of San Francisco, and honoring the countless
5	contributions of the Asian Pacific American community.
6	
7	WHEREAS, The month of May carries significance to Asian Pacific Americans because
8	of two historic events that occurred on May 7, 1843, the date in which the first Japanese
9	immigrants arrived to the United States; and May 10, 1869, Transcontinental Chinese
10	Railroad Workers Day, in recognition of the contributions of Chinese immigrants that worked
11	to complete the first transcontinental railroad in the United States despite discriminatory,
12	unsafe conditions; and
13	WHEREAS, The origin of the Asian Pacific American Heritage Month came from a
14	former Capitol Hill staffer, Jeanie Jew, who illuminated the need for the recognition of this
15	important community in highlighting her own story as a great granddaughter of a Chinese
16	Transcontinental worker and Ruby Moy, the chief of staff of Representative Horton who
17	worked to make the commemoration possible; and
18	WHEREAS, Congressional representatives dating back to 1977 introduced resolutions
19	to designate official recognition for Asian Pacific Heritage, which eventually recognized the
20	first week of May as Asian/Pacific American Week; and
21	WHEREAS, On March 28, 1979, President Carter issued the first presidential
22	proclamation for Asian/Pacific American Heritage Week to recognize the significant
23	contributions of the Asian Pacific community; and

WHEREAS, In 1991, United States President George H.W. Bush signed into law a

Joint Resolution adopted by the Congress of the United States, declaring that the month of

1	May be celebrated as Asian Pacific American Heritage Month in the United States in
2	perpetuity; and
3	WHEREAS, San Francisco has a significant Asian Pacific population and has
4	celebrated Asian Pacific Heritage Month annually;
5	WHEREAS, In 2005, Mayor Gavin Newsom embraced the idea of an annual official
6	celebration of Asian Pacific American Heritage Month in San Francisco with festivities
7	coordinated and organized by a diverse group of community representatives serving on the
8	Asian Pacific American (APA) Heritage Celebration Committee; and
9	WHEREAS, Since 2005, San Francisco's annual celebration event of Asian American
10	Heritage Month historically took place on the first Monday of May; and
11	WHEREAS, The San Francisco Board of Supervisors also honored notable Asian
12	Pacific residents and organizations in each of the eleven Supervisorial Districts for community
13	service, contributions, and achievements during a Special Commendation Ceremony for
14	Asian Pacific American Heritage Month at an official Board Meeting in May; and
15	WHEREAS, Due to the global pandemic caused by COVID-19 and the Shelter-in-Place
16	order in San Francisco and throughout California, Asian Pacific American Heritage Month
17	celebrations are postponed or are being done virtually; and
18	WHEREAS, The Board of Supervisors suspended Special Commendations during the
19	Shelter-in-Place;
20	WHEREAS, The celebration of the Asian Pacific American community is important now
21	more than ever given the rise of anti-Asian sentiment nationwide due to xenophobia and
22	racism related to the global COVID-19 health pandemic; and
23	RESOLVED, That the Board of Supervisors recognizes and celebrates the month of
24	every May as Asian Pacific American Heritage Month; and

1	FURTHER RESOLVED; That the Board of Supervisors will participate and support
2	events and campaigns to highlight the achievements and contributions of the Asian Pacific
3	community; and, be it
4	FURTHER RESOLVED, That the Board of Supervisors will continue to support the
5	Asian Pacific community during this time of crisis to ensure that basic services and protection
6	are provided during this health emergency; and, be it
7	FURTHER RESOLVED, That the Board of Supervisors commends the work of the
8	Asian Pacific American Heritage Celebration Committee and the Asian Pacific American
9	Heritage Foundation for making these events possible; and, be it
10	FURTHER RESOLVED, That the Board of Supervisors commends the Center for
11	Asian American Media (CAAM), Asian Art Museum, and the San Francisco Public Library for
12	their partnership in producing and promoting the activities to celebrate Asian Pacific American
13	Month.
