2 Resolution supporting the creation of a regional lifeline  
3 transit network, urging the Metropolitan Transportation  
4 Commission (MTC) to complete the Lifeline Transit Network and  
5 fully fund its implementation in the Regional Transportation  
6 Plan (RTP) and urging MTC to adopt lifeline transportation  
7 measures for projects proposed for the regional transit  
8 expansion program (RTEP).

10 WHEREAS, the San Francisco Bay Area is one of the most  
11 congested regions in the country and the area needs a long term  
12 transit strategy that unifies Bay Area leadership and reflects  
13 local priorities; and

14 WHEREAS, A Lifeline Transit Network would identify transit  
15 routes that should extend service to nights and weekends, along  
16 with routes that should increase frequency to help low-income  
17 families access jobs, schools and services; and

18 WHEREAS, The Metropolitan Transportation Commission (MTC)  
19 has not completed its Lifeline Transit Network or funded the  
20 program; and

21 WHEREAS, The Regional Transit Expansion Policy would be  
22 approach regional transit policy with a desire to find rough  
23 consensus among local leadership in the Bay Area for transit  
24 expansion projects which would include rail extensions,

1 construction of bus and rail stations and funding for new  
2 busses; and

3 WHEREAS, The RTEP is a desirable approach for Bay Area  
4 transit planning because officials will have unity when lobbying  
5 for state and federal money, as well as securing unified local  
6 support for regional projects; and

7 WHEREAS, If the MTC completed its Lifeline Transit Network  
8 the list of expanded service lines could be added to the RTEP,  
9 adding an important component to the plan which would address  
10 low income transit use; now, therefore be it

11 RESOLVED, That the City and County of San Francisco  
12 supports the development and adoption by MTC of a regional  
13 Lifeline Transit Network, which addresses the critical mobility  
14 needs of low income communities and transit-dependent  
15 populations in the Bay Area, including seniors, youth, people  
16 with disabilities, low income people, and people moving from  
welfare to work; and be it

17 FURTHER RESOLVED, That the 2001 Regional Transportation  
18 Plan being prepared by the Metropolitan Transportation  
19 Commission should fund implementation of the regional Lifeline  
20 Transit Network; and be it

21 FURTHER RESOLVED, That the Regional Transportation  
22 Expansion Plan being prepared by the Metropolitan Transportation  
23 Commission should be integrated with the Lifeline Transit  
24 Network, and that the performance criteria for proposed projects




