RESOLVED, That the Board of Supervisors adopts as its own and incorporates by reference herein, as though fully set forth, the findings made by the City Planning Department in its letter dated August 1, 1997 that the acquisition of said real property is in conformity with the General Plan and consistent with the Eight Priority Policies of City Planning Code Section 101.1; and, be it

FURTHER RESOLVED, That the Board of Supervisors hereby approves the acquisition of the subject property for \$115,500 according to the terms and conditions of the Agreement of Purchase and Sale for Real Estate and hereby authorizes the Director of Property to accept the grant deed and execute any other necessary documents to acquire the subject property from John L. Goodrich. Said acquisition shall be subject to the certification of funds by the Controller pursuant to Section 3.105 of the Charter.
