6 WHEREAS, The San Francisco Municipal Transportation Agency (SFMTA) issues 1.9  
7 million parking citations per year; and,

8 WHEREAS, Assistance is required to process parking citations, to procure handheld  
9 ~~ticket-writing devices and manage collections activities through use of sophisticated~~  
10 information systems and software; and,

11 WHEREAS, The San Francisco Municipal Transportation Agency Board of Directors  
12 adopted Resolution 08-141 on August 6, 2008, awarding a five-year contract for these  
13 services which is on file with the Clerk of the Board of Supervisors in File No. 081168 which is  
14 hereby declared to be a part of this resolution as if set forth herein; and,

15 WHEREAS, A Request for Proposal was released on December 6, 2006 in response  
16 to which PRWT Services, Inc. submitted the only proposal; and,

17 WHEREAS, after a thorough technical review process conducted by the SFMTA,  
18 PRWT Services, Inc. met the minimum qualifications and the 6 percent Local Business  
19 Enterprise (LBE) subcontracting goal, and was found to be responsive and responsible; and,

20 WHEREAS, the SFMTA is requesting the Board of Supervisors approve the  
21 Agreement with PRWT Services, Inc.; now, therefore, be it

22 RESOLVED, That the Board of Supervisors authorizes the San Francisco Municipal  
23 Transportation Agency to execute the Agreement for Parking Citations Processing Services,  
24 for a term of five years, with option to renew for up to an additional five years, for an amount  
25 not to exceed \$45,815,441 for non-optional services and \$7,660,000 for optional services

1 \$53,500,000 in substantially the form on file with the Clerk of the Board of Supervisors in File  
2 No. 081168 which is hereby declared to be a part of this resolution as if set forth herein.
