3 **Resolution urging the Mayor to maintain funding levels for services for older adults**  
4 **and adults with disabilities served by and through the Department of Aging and Adult**  
5 **Services.**

7 WHEREAS, San Francisco is home to over 200,000 older adults and adults with  
8 disabilities; and

9 WHEREAS, The well-being and needs of this population being served is an obligation  
10 of the City and cannot be ignored; and,

11 WHEREAS, The San Francisco Department of Aging and Adult Services was  
12 established with a mandate to integrate services for older adults and adults with disabilities  
13 with manifest understanding that said integration of the Departments would incur the need for  
14 revenues that are not forthcoming; and

15 WHEREAS, There is a serious budget crisis in the City and County of San Francisco  
16 and the State of California; and,

17 WHEREAS, The Department of Aging and Adult Services has been directed to cut  
18 General Funding by 10% in Fiscal Year 2003-04 with a contingency plan to cut an additional  
19 10%; and,

20 WHEREAS, These cuts will result in a severe hardship to vulnerable older adults and  
21 adults with disabilities by reducing the number of contracted services such as congregate and  
22 home-delivered meals, emergency in-home supportive services and other community  
23 services; and,

24 WHEREAS, The Department of Aging and Adult Services serves older and dependent  
25 adults in need of protection because of abuse and neglect or in need of assistance to manage

1 their personal affairs due to mental and physical incapacity; and these consumers often have  
2 no other options for these vital services; and,

3 WHEREAS, Services provided by and through the Department of Aging and Adult  
4 Services are critical in the management of risks and acute interventions for older adults and  
5 adults with disabilities and these services are comparably lower and prevent the need for  
6 higher cost interventions by the Department of Public Health at San Francisco General  
7 Hospital and Laguna Hospital; and,

8 WHEREAS, The Department of Aging and Adult Services has not been provided  
9 sufficient funds for infrastructure, and is already seriously challenged in providing the services  
10 it is mandated to provide; and,

11 WHEREAS, The amount of money saved by the proposed cuts would be less than one  
12 quarter of one percent of the City budget deficit; and,

13 WHEREAS, The Aging and Adult Services Commissioners are opposed to cuts to  
14 funding for senior services; now, therefore, be it

15 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
16 does hereby support and agrees with the San Francisco Aging and Adult Services  
17 Commission in opposition to said budgets cuts for senior services; and, be it

18 FURTHER RESOLVED, That the Board of Supervisors does hereby ~~urge the Mayor to~~  
19 support maintaining the funding ~~maintain funding~~ levels for services for older adults and adults  
20 with disabilities served by and through the Department of Aging and Adult Services.




