1	[[Resolution—Renaming the Biodiesel Access Taskforce to the Biofuels Citizen's Advisory
2	Committee, Expanding its membership and establishing a Sunset Date]]
3	
4	Resolution renaming the Biodiesel Access Taskforce the Biofuels Citizen's Advisory
5	Committee, establishing its sunset date, establishing the number of voting members of
6	the CAC, appointing certain members of the Taskforce to the CAC, and directing the
7	CAC to establish biofuels sustainability standards.
8	
9	WHEREAS, Biodiesel use has grown significantly, expanding the array of tasks and
10	issues that must be addressed to facilitate the public's adequate access to alternative fuels;
11	and,
12	WHEREAS, Biodiesel is a clean burning, renewable, American-made fuel that helps
13	reduce America's dependence on foreign oil; and,
14	WHEREAS, Resolution 82-06 that established the Biodiesel Access Taskforce
15	(Taskforce) was unanimously approved by the Board of Supervisors and adopted February
16	14, 2006; and,
17	WHEREAS, Biodiesel has been established as being the only alternative for
18	automobiles that will decrease any contribution to global warming; and,
19	WHEREAS, Biodiesel has the potential to not only fuel automobiles, but represents an
20	alternative for water heaters, boats, construction equipment, and other petroleum-relying
21	services; and,
22	WHEREAS, The Taskforce has fostered an array of alternatives to fossil fuels,
23	including a biofuel blend of biodiesel and diesel; and,
24	WHEREAS, The Taskforce has worked with the Mayor Office and various City
25	departments on the City's successful conversion to B20; and,

1	WHEREAS, Biofuel must be fostered explicitly in compliance with the standards
2	outlined by ASTM International; and,
3	WHEREAS, The Taskforce has been assisting entrepreneurs in opening a biodiesel
4	only filling station; and,
5	WHEREAS, The Taskforce worked to resolve issues surrounding biodiesel storage
6	with the State Water Board and the California Biodiesel Alliance that allowed for B20 to be
7	accepted statewide underground storage; and,
8	WHEREAS, The Taskforce has collaborated with the Department of Health to
9	establish discretionary fee waivers for B100 dispensing; and,
10	WHEREAS, The Taskforce has become a center of expertise for California State
11	agencies and Federal government agencies as they begin to evaluate the proper regulation
12	and promotion of alternatives to fossil fuels, including biodiesel; now, therefore, be it,
13	RESOLVED, The Biodiesel Access Taskforce is hereby renamed the Biofuels Citizen's
14	Advisory Committee (Biofuels CAC) in order to reflect the array of alternatives available to the
15	City and County of San Francisco, continue San Francisco's illustrious legacy of setting a
16	national standard for innovative policy and is hereby granted sunset date of December 31,
17	2015, and, be it
18	FURTHER RESOLVED, The Board of Supervisors shall appoint seven (7) members of
19	the public that represent the biofuels community such as gas station owners, fleet operators,
20	consumers, waste cooking oil collectors and biofuels producers. Such community members
21	may include organizations provided that no organization shall have more than one
22	representative on the Biofuels CAC; and, in the event a vacancy occurs, the Board of
23	Supervisors shall appoint a successor to complete the remainder of the term; and, be it,
24	FURTHER RESOLVED, The three (3) currently serving public members of Taskforce,
25	and all non-voting agency appointed members of the Taskforce are hereby appointed to the

1	Biofuels CAC, with the Public members' terms expiring on December 31, 2013, to provide for
2	continuity so that the Biofuels CAC may embark on its work with minimum disruption; and, be
3	it,.
4	FURTHER RESOLVED, The remaining four (4) voting seats on the Biofuels CAC
5	reserved for members of the public shall be appointed by the Board of Supervisors at the
6	earliest time possible for a term to expire on December 31, 2015; and, be it
7	FURTHER RESOLVED, The Biofuels CAC shall work with the Mayor's Office and City
8	agencies to both expand and continue the successful implementation of the City's biofuel
9	program; and, be it
10	FURTHER RESOLVED, The Biofuels CAC shall establish standards for sustainability
11	applicable to biodiesel and the City's purchase of biodiesel for use in City vehicles; and, be it
12	FURTHER RESOLVED, The Biofuels CAC shall undertake any additional biofuel-
13	related matters that it deems appropriate and necessary for encouraging biofuel use in the
14	City including, but not limited to, expanding public access to biofuels and educating the
15	maritime and construction industry sectors on use and advantages of biofuels.
