4 **Resolution authorizing the Airport Commission to accept and expend a grant totaling**  
5 **\$44,000 from the Federal Transit Administration through the California Department of**  
6 **Transportation (CalTrans) and the Metropolitan Transportation Commission (MTC) for**  
7 **ground transportation planning interns.**

9 WHEREAS, The California Department of Transportation (CalTrans) through the  
10 Metropolitan Transportation Commission (MTC) administers grant funds from the Federal  
11 Transit Administration to public transportation agencies for transportation planning internship  
12 programs; and,

13 WHEREAS, The San Francisco International Airport (Airport) has a large and highly  
14 successful ground transportation program that includes services provided by three major Bay  
15 Area public transportation operators and numerous private transportation operators and seeks  
16 to hire two (2) part-time 5276 – City Planning Interns and provide them meaningful training  
17 experience; and,

18 WHEREAS, The Airport Commission in Resolution #05-0130 approved seeking,  
19 accepting, and expending these grant funds for ground transportation planning interns; and,

20 WHEREAS, The Airport has budgeted \$6,000 (Six Thousand and 00/100 Dollars) in  
21 the Airport Commission budget for the Fiscal Year commencing July 1, 2005 as matching  
22 funds as required by CalTrans; and,

23 WHEREAS, The Airport proposes to maximize the use of available grant funds by not  
24 including indirect costs in the grant budget; now, therefore, be it




FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in the grant budget; and be it


