Resolution declaring February 28, 2025, as Jesse Capin Smith Day in the City and County of San Francisco, in recognition of his many years of outstanding service and dedication to the City and County of San Francisco and his well-deserved retirement.

WHEREAS, Jesse Capin Smith joined the City Attorney's Office as a Deputy City Attorney 32 years ago, beginning a storied career first as a real estate and economic development lawyer and later overseeing all the City Attorney's Office's legal advice and transactions work, including opinions to the Mayor, Board of Supervisors, and other City officials, departments and commissions; legislation and memoranda; and legal advice regarding every aspect of City government; and

WHEREAS, Jesse joined the City Attorney's Office in 1992 as a Deputy on the Real Estate & Special Projects Team, later the Real Estate & Finance Team, and then served as its Team Leader; and

WHEREAS, City Attorney Louise Renne selected Jesse to serve as Chief Assistant City Attorney in 2000; and since then he has led the City Attorney's Office through three City Attorney administrations, as the longest tenured Chief Assistant in the Office's history; and

WHEREAS, Jesse's impact on the City Attorney's Office and San Francisco cannot be overstated; in all matters, he led by example, always thorough, thoughtful, and creative, with a clear understanding of the legal and ethical issues, larger context, and ultimate goals of the City Attorney's clients; and

WHEREAS, He created the City Attorney's standards and processes for advising City agencies and officials, ensured continuity when there were changes in City government, and consistently worked for the good of the City and County of San Francisco; and

WHEREAS, As Chief Assistant, Jesse meaningfully impacted every significant effort
the City Attorney's Office has undertaken in the last 25 years: with a background in real
estate, he had a hand in the major projects that have shaped our City skyline, including
Mission Bay, the Giants ballpark, the Warriors arena, and the City Hall retrofit and renovation;
and using his creative and practical problem-solving, Jesse championed public-private
partnerships like the San Francisco Boys & Girls Club in Hunter's Point; and

WHEREAS, Jesse always met the moment, a steely and strategic thinker ready to meet the challenges of our time—whether it was helping spearhead cross-team efforts to hold the Trump Administration accountable, prioritizing public integrity work to ensure City government is held to the highest ethical standards, saving Laguna Honda Hospital from closure, or most recently, acting as the key architect of San Francisco's response to COVID-19, it is not an exaggeration to say Jesse's efforts leave an indelible mark on the City Attorney's Office, on San Francisco, and on the legal profession; and

WHEREAS, Jesse has been a mentor, teacher, and moral and intellectual model to generations of attorneys and professional staff in the City Attorney's Office; he is living proof that a person can be incredibly talented and remarkably kind – a combination that makes Jesse so extraordinary; and

WHEREAS, He is often the first to reach out to colleagues in the City Attorney's Office and many other departments to celebrate joyful moments, or to offer empathy and support when someone faces personal challenges; and

WHEREAS, Jesse had a particularly outsized impact on this Board of Supervisors, supervising all the legal advice the Board has received for a quarter century, approving every confidential memorandum the Board received, and shepherding the City Attorney's response to every crisis the Board has confronted; and

1	WHEREAS, Even City officials who have not worked with him directly have benefited
2	from Jesse's moral clarity, legal acumen, and steady hand behind the scenes in the City
3	Attorney's Office; and
4	WHEREAS, The City Attorney's Office, the Board of Supervisors, and the City as a
5	whole are immeasurably better for Jesse's service; and
6	WHEREAS, Jesse intends to retire in late February 2025, leaving us with the weight of
7	his absence but also with the gift of his legacy; now, therefore, be it
8	RESOLVED, That in celebration of Jesse's outstanding accomplishments and
9	contributions to the City and County of San Francisco, the Board of Supervisors does hereby
10	declare February 28, 2025, to be Jesse Capin Smith Day in San Francisco.
