10 Property is hereby authorized to purchase and accept on behalf of the City noise easement deeds from  
11 the owners of those properties as shown on the lists marked as attachment A, B, C, D and E, a copy  
12 of each is on file with the Clerk of the Board of Supervisors in file no. 000609, and, be it

13 RESOLVED, That the cost to acquire said easements shall not exceed such portion of the  
14 noise mitigation program's aggregate amount of \$120,000,000, with each easement deed to expire  
15 twenty (20) years from the date of recordation, and, be it

17 FURTHER RESOLVED, That the City Attorney will approve the title and form of the grant  
18 of easement.




