

1 [Expand and evaluate substance abuse services in San Francisco.]

3 Resolution authorizing the San Francisco Department of Public Health (SFDPH) to
4 accept and expend retroactively a grant in the amount of \$1,105,000 from the
5 Substance Abuse and Mental Health Services Administration (SAMHSA) and the Center
6 for Substance Abuse Treatment (CSAT), for the period of August 1, 2001, to July 31,
7 2002.

9 WHEREAS, The SFDPH has applied for and been awarded a grant from
10 SAMHSA/CSAT for expanding and evaluating substance abuse treatment services in San
11 Francisco; and,

12 WHEREAS, SAMHSA/CSAT has agreed to reimburse the SFDPH in the amount of
13 \$1,105,000 under the terms of this award; and,

14 WHEREAS, As a condition of receiving the funds SAMHSA/CSAT requires the SFDPH
15 to enter into an agreement ("The Agreement"), "Terms and Conditions of Award", a copy of
16 which is on file with the Clerk of the Board of Supervisors in File No. 011829, which is
17 hereby declared to be a part of this resolution as if set forth fully herein; and,

18 WHEREAS, The grant budget includes provision for indirect costs of \$32,008; now,
19 therefore, be it

20 RESOLVED, That the SFDPH is hereby authorized to accept and expend retroactively
21 a grant in the amount of \$1,105,000 from SAMHSA/CSAT; and, be it

22 FURTHER RESOLVED, That the SFDPH is hereby authorized to accept and expend
23 the grant funds in accordance with the requirements set forth in the Agreement pursuant to
24 San Francisco Administrative Code section 10-170-1; and, be it




1 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
