

- Please describe the experience you have in public health programs related to diabetes, oral health, obesity, and sugary drink consumption.

The experiences I have had related with health problems caused by sugary drinks have been through research and education in my school. As part of our economics course curriculum, I have had the opportunity to directly study and present to my peers the impact of the sugary drink distributor tax on public health and personal income. This included an in-depth analysis of the negative impact obesity has on both an individual's quality of life and standard of living, as well as the particularly harmful physical and emotional effects of childhood obesity on the future development of young people. Considering that this condition can be caused by high consumption of sugary beverages, the benefits to public health of the sugary drink distributor tax quickly became apparent.

More directly, I have had experience in public health programs related to the homeless community of San Francisco. I have been a volunteer at Community Housing Partnership (CHP) over the past 9 months. CHP is a local nonprofit working to help secure housing and advance public policy supporting members of the homeless community. Most recently, our advocacy program has been focusing on ensuring San Francisco implements a treatment on demand (TOD) program per a 2008 ballot measure. TOD entails providing any member of the homeless community with substance abuse or mental health issues free treatment from the city, noting that the two issues are in many cases interlinked. While I was with CHP, I was responsible for outreach to community members about their public health and treatment needs, community leaders about their proposals regarding TOD, and city government officials regarding current programs and information from past attempts at TOD. While this was not directly related to the public health issues caused by sugary drinks, it nevertheless gave me the opportunity to engage with a different area of the public health issues and programs present in our city.

- Please describe the ways in which sugary drinks impact diverse communities across San Francisco.

Sugary drinks impact the diverse range of communities across San Francisco by directly causing or increasing risk factors for significant health issues. The effects of sugary drinks can be seen to impact the consequential community of youth in San Francisco in particular. Slightly more than 24% of youth in the city are estimated to drink one or more sugary drink per day. In addition, 15.6% of kids age 10-17 and an even higher 16.6% of kids age 2-4 are currently obese. Noting that sugary drinks are a well-established cause of childhood obesity, it is not difficult to see the potential link between consumption of these beverages and the development of dangerous health conditions. Furthermore, the effects of obesity and other sugary drink related health conditions such as poor oral health can lead to low self-esteem, depression, bullying, sleep issues, increased risk for cardiovascular disease, cancer, and diabetes, as well as future growth and development impairments. The consumption of highly sweetened drinks adversely impacts the future health and wellbeing of future San Franciscans in an undeniable way.

Another disproportionate impact the consumption of sugary drinks has is on communities of color. Due to a higher lack of access to healthy alternatives, consumption of sugary drinks has historically been higher in communities of color. This can be seen firsthand in the Bayview, Tenderloin, and Oceanview neighborhoods, which have no big-box grocery stores. As a result of higher rates of

consumption, it is an unfortunate fact that these communities also face higher rates of obesity and other sugar related health issues; 57% of African Americans and 50% of Latinx pupils in the 9th grade are overweight or obese. While Supervisor Malia Cohen and former Supervisor Eric Mar's pilot program to help reduce this inequity in 2013 has made progress, much more work is needed. With the sugary drink distributor tax, hopefully this inequity can be eliminated.

- Please describe your experience in community-based outreach.

As part of my work listed above with Community Housing Partnership (CHP), I had the great opportunity to meet with individuals and leaders in the homeless community to help compile a history of TOD and better understand the needs of the people I was working for. With this information, I compiled a report for (CHP) on the history of TOD in San Francisco and the most pressing needs of the communities which a new TOD program would serve. This ultimately culminated in a presentation to Supervisor Rafael Mandelman and the representatives of several bay-area organizations working to implement TOD. This community outreach was a truly fulfilling experience, and I hope to have the chance to use this experience to further the work of the Sugary Drink Distributor Tax Advisory Committee (SDDTAC).

In addition to my community-based outreach experience with CHP, I have also had the honor to help intern in Senator Feinstein's office here in San Francisco. As part of this internship, I was able to understand the needs of constituents throughout California, respond to their worries and concerns, and gain knowledge of the policy processes behind the services the government provides, all skills that I hope to bring to the SDDTAC.

- Please describe how your work or life experience will inform the work of the committee.

I hope to help inform the work of the SDDTAC with what I have learned in the classroom regarding the impacts of sugary drinks and regressive taxes as well as my work experience with CHP and Senator Feinstein's office. Through my research in school regarding the sugary drink distributor tax, I appreciate the fact that a per unit tax on the consumption of goods is regressive in nature since it does not consider the income of the person being taxed. Thus, I believe it is a necessity that the revenues of this tax be allocated to programs that enhance the availability of healthy alternatives to communities traditionally impacted by sugary drinks and mitigative programs that reduce the harmful health effects of high sugar consumption. Through expanding the programs already implemented by the SDDTAC, like increased funding for SFUSD water fountains, and developing new initiatives to reduce the consumption of sugary drinks and improve public health, the revenues of this tax can be utilized to their full potential.

In addition, the work I have done with Senator Feinstein's office and CHP has informed me of the importance of community outreach and support for success in government policy. From these experiences I believe that the SDDTAC must remain connected with the diverse community of San Franciscans it serves. If it becomes isolated, it loses its representative power and the ability to most effectively implement change for the communities who need it most. Therefore, I hope to utilize my personal experiences with outreach across San Francisco to further connect the SDDTAC to the constituents it serves and develop the most effective policy proposals to counteract sugary drinks as possible.

RE: Youth Commission Recommendations for Seat 6 on the Sugary Drinks Distributor Tax
Advisory Committee (SDDTAC)

Pursuant to Administrative Code, Chapter 5, Article XXXIII, Sections 5.33-2, seat 6 on the Sugary Drinks Distributor Tax Advisory Committee is reserved for "[a person who is under 19 years old at the time of appointment and who may be a member of the Youth Commission, nominated by the Youth Commission and appointed by the Board of Supervisors. If the person is under legal voting age and unable to be an elector for that reason, the person may hold this seat, but upon reaching legal voting age, the person shall relinquish the seat unless he or she becomes an elector, in which case the person shall retain the seat]".

In order to fulfill their duties outlined in the administrative code concerning recommendations for seat 6, Youth Commissioners conducted an outreach and application process in which they reached out to youth-serving community organizations across San Francisco to help identify youth interested in serving on the SDDTAC. Youth Commissioners considered applications at their Wednesday, March 27, 2019 Executive Committee meeting. Youth Commissioners reviewed the Sugary Drinks Distributor Tax legislation (BOS File No.160729), working carefully to select youth who they believe can provide valuable insight on the diverse experiences and challenges of young people in San Francisco, as well as bring a systems-informed and solution-oriented lens to the work of the SDDTAC.

Youth Commissioners are pleased to share their **recommendation of Aaron Kunz for appointment consideration to seat 6 on the SDDTAC**. Youth Commissioners found that Aaron is well positioned to bring unique and important insights to the work of the SDDTAC through their own experiences and challenges as a young San Franciscan, as well as their dedication to improving health outcomes for young people in our City. Their full application is attached for your review.

1 The Youth Commission is nominating Aaron Kunz to the Sugary Drinks Distributor Tax Advisory
2 Committee's Youth Seat. Aaron Kunz will bring his living experiences to maximize the collective
3 community voice. Aaron brings a critical analytical lens to problem solve with the committee the ways in
4 which sugary drinks have impacted low – income people of color communities across San Francisco.
5 As the youth seat, the Youth Commission trusts that Aaron will move the committee to remain connected
6 with the community. He understands that there needs to be an equity lens to the work and the tax should
7 benefit the community. He believes that it is a necessity that the revenues of this tax be allocated to
8 programs that enhance the availability of healthy alternatives to communities historically impacted by
9 sugary drinks and invest in community health programs that reduce the harmful health effects of high
10 sugar consumption. With his research and community outreach experience through Community
11 Housing Partnership and interning at Senator Feinstein's office, he is adept and able to work with
12 community on educating and uplifting their needs from grassroots to policy making level. And most
13 importantly, he is willing to commit the time and energy to be a vital voice for youths and families on the
14 SDTAC.

Board Qualifications:

The general purpose of the Advisory Committee is to make recommendations to the Mayor and the Board of Supervisors on the effectiveness of the Sugary Drinks Distributor Tax in Business Tax and Regulations Code Article 8.

The Advisory Committee shall consist of the following 16 voting members:

(a) Seats 1, 2, and 3 shall be held by representatives of nonprofit organizations that advocate for health equity in communities that are disproportionately impacted by diseases related to the consumption of Sugar-Sweetened Beverages, as defined in Business and Tax Regulations Code Section 552, appointed by the Board of Supervisors.

(b) Seats 4 and 5 shall be held by individuals who are employed at medical institutions in San Francisco and who have experience in the diagnosis or treatment of, or in research or education about, chronic and other diseases linked to the consumption of Sugar-Sweetened Beverages, appointed by the Board of Supervisors.

(c) Seat 6 shall be held by a person who is under 19 years old at the time of appointment and who may be a member of the Youth Commission, nominated by the Youth Commission and appointed by the Board of Supervisors. If the person is under legal voting age and unable to be an elector for that reason, the person may hold this seat, but upon reaching legal voting age, the person shall relinquish the seat unless he or she becomes an elector, in which case the person

shall retain the seat.

(d) Seat 7 shall be held by a person appointed by the Director of the Office of Economic and Workforce Development or any successor office.

(e) Seats 8 and 9 shall be held by persons appointed by the Board of Education of the San Francisco Unified School District. If at any time the Board of Education declines to appoint a member to Seat 8 or 9 and leaves the seat vacant for 60 days or longer, the Board of Supervisors may appoint a member of the public to fill the seat until such time as the Board of Education appoints a member.

(f) Seat 10 shall be held by an employee of the Department of Public Health who has experience or expertise in the field of chronic disease prevention or treatment, appointed by the Director of Health.

(g) Seat 11 shall be held by a person with experience or expertise in the field of oral health, appointed by the Director of Health.

(h) Seat 12 shall be held by a person with experience or expertise in the field of food security or access, appointed by the Director of Health.

(i) Seat 13 shall be held by an employee of the Department of Children, Youth & Their Families, appointed by the Director of that Department.

(j) Seat 14 shall be held by an employee of the Recreation and Park Department, appointed by the General Manager of that Department.

(k) Seat 15 shall be held by a parent or guardian of a student enrolled in the San Francisco Unified School District at the time of appointment, nominated by the San Francisco Unified School District's Parent Advisory Council, and appointed by the Board of Supervisors. If at any time the Parent Advisory Council declines to nominate a member to a vacant seat for 60 days or longer, the Board of Supervisors may appoint a member of the public to fill the seat until the seat becomes vacant again.

(l) Seat 16 shall be held by a person with experience or expertise in services and programs for children five and under, appointed by the Board of Supervisors.

Appointing authorities shall make initial appointments to the Advisory Committee by no later than September 1, 2017. The initial term for each seat on the Advisory Committee shall begin September 1, 2017, and end on December 31, 2018.

Any member who misses three regular meetings of the Advisory Committee within any 12-month period without the express approval of the Advisory Committee at or before each missed meeting shall be deemed to have resigned from the Advisory Committee 10 days after the third unapproved absence. The Advisory Committee shall inform the appointing authority of any such resignation.

The City Administrator shall provide administrative and clerical support for the Advisory Committee, and the Controller's Office shall provide technical support and policy analysis for the Advisory Committee upon request. All City officials and agencies shall cooperate with the Advisory Committee in the performance of its functions.

Report: Starting in 2018, by March 1 of each year, the Advisory Committee shall submit to the Board of Supervisors and the Mayor a report that (a) evaluates the impact of the Sugary Drinks Distributor Tax on beverage prices, consumer purchasing behavior, and public health, and (b) makes recommendations regarding the potential establishment and/or funding of programs to reduce the consumption of Sugar-Sweetened Beverages in San Francisco. Within 10 days after the submission of the report, the City Administrator shall submit to the Board of Supervisors a proposed resolution for the Board to receive the report.

Sunset: December 31, 2028.

Vacant Seat 6, succeeding Areeya Chanandech, resigned, must be a person who is under 19 years old at the time of appointment and who may be a member of the Youth Commission, nominated by the Youth Commission and appointed by the Board of Supervisors, for a two-year term ending December 31, 2020. 

Members of the Rules Committee will consider the appointment(s) at the meeting and applicant(s) will be asked to present their qualifications. The appointment(s) of the individual(s) who are recommended by the Rules Committee will be forwarded to the Board of Supervisors for final approval.
