WHEREAS, Pillsbury was instrumental in forming Pacific Telephone & Telegraph, predecessor to Pacific Bell, in 1887, and Pacific Coast Oil Company, predecessor to Chevron Corporation; and,

WHEREAS, Pillsbury survived the earthquake and Great Fire of 1906 and went on to become the preeminent law firm in the State of California; and,

WHEREAS, Pillsbury served as the United Nations Charter Conference Executive Secretary in 1945 and was instrumental in ensuring that the Charter was appropriately drafted, signed and delivered to Washington, D.C.; and,

WHEREAS, Pillsbury has helped create a positive environment for the development of mass transit in California and the Bay Area by providing legal counsel and assistance to BART since its inception; and,

WHEREAS, Pillsbury demonstrated its long standing commitment to San Francisco by donating money and countless pro bono hours following the 1989 Loma Prieta Earthquake to help the City deal with a back-log of pending litigation; and,

WHEREAS, Pillsbury created the John A. Sutro Public Service Fellowship to help provide education and legal assistance to economically disadvantaged members of the San Francisco and California communities; and,

WHEREAS, Pillsbury was instrumental in helping San Francisco keep the Giants baseball team in the City by providing the legal and business advice and assistance that created

1 the partnership that is constructing Pac Bell Park; and,

2 WHEREAS, Pillsbury recognized, early on, the benefits to California and the nation of
3 high technology and the Internet and provided the needed legal counsel and advice to help many
4 high technology and Internet companies get started and become public; and,

5 WHEREAS, Pillsbury has been a national and State leader among major law firms in
6 hiring minorities and women and moving them into positions of leadership; and,

7 WHEREAS, Pillsbury has been a major contributor to the quality of civic and economic
8 life in the City of San Francisco and the State of California for 125 years; now, therefore, be it

9 RESOLVED, the San Francisco Board of Supervisors congratulates Pillsbury Madison
10 & Sutro LLM on their 125th Anniversary and thanks the firm for more than a century of


