
Dear Mr. Gebb:

11 WHEREAS, The Drunken Monkey, Inc., dba Docs Clock is seeking the transfer
12 of a Type 48 on-sale general public premises license located at 2417 Mission Street
13 (District 9); and

14 WHEREAS, The Planning Department has verified that the area is properly
15 zoned and recommends approval; and

16 WHEREAS, The Police Department has filed zero (0) protests and zero (0)
17 letters of support with the Department of Alcoholic Beverage Control under California
18 Business and Professions Code, Section 24013, and recommends that the Department
19 of Alcoholic Beverage Control issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department are the
21 following: 1) sales, service, and consumption of alcoholic beverages shall be permitted
22 between the hours of 10:00 a.m. and 2:00 a.m. daily; 2) no noise shall be audible
23 beyond the area under the control of the licensee(s); 3) the sales of alcoholic beverages
24 for off-sale consumption is strictly prohibited; 4) the sales and services of alcoholic
25 beverages shall be conducted at the bar or provided by an employee server; bottle

1 service and self-service of alcoholic beverages is strictly prohibited; 5) the petitioner(s)
2 shall be responsible for maintaining free of litter the area adjacent to the premises over
3 which they have control; 6) loitering (defined as "to stand idly about; linger aimlessly
4 without lawful business") is prohibited on any sidewalks or property adjacent to the
5 licensed premises under the control of the licensee; 7) the exterior of the premises shall
6 be equipped with lighting of sufficient power to illuminate and make easily discernible
7 the appearance and conduct of all persons on or about the premises; additionally, the
8 position of such lighting shall not disturb the normal privacy and use of any neighboring
9 residences; and 8) graffiti shall be removed from the premises and all parking lots under
10 the control of the licensee(s) within 72 hours of application; if the graffiti occurs on a
11 Friday or weekend day, or on a holiday, the licensee(s) shall remove the graffiti within
12 72 hours following the beginning of the next weekday; now, therefore, be it

13 RESOLVED, That in accordance with California Business and Professions Code,
14 Section 23958.4, the Board of Supervisors of the City and County of San Francisco
15 hereby determines that the transfer of a Type 48 on-sale general public premises
16 license to The Drunken Monkey, Inc., dba Docs Clock located at 2417 Mission Street
17 (District 9), will serve the public convenience or necessity of the City and County of San
18 Francisco; and, be it

19 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
20 San Francisco hereby endorses and adopts the recommendations of the Police
21 Department listed above, and recommends that the Department of Alcoholic Beverage
22 Control issue the license with those conditions.




