RESOLVED, That in accordance with Section 23958.4 of the California Business and Professions Code, the Board of Supervisors of the City and County of San Francisco hereby determines for the foregoing reasons that the issuance of a Type 9 beer and wine importer license, a Type 17 beer and wine wholesaler license, and a Type 20 off-sale beer and wine alcoholic beverage control license, to Carl Jager for The Scott Street Portfolio, located at 231 Scott Street will serve the convenience of the people of the City and County of San Francisco.

Condition: Subject premises will be solely a business office and no alcoholic beverages will be possessed, stored, or delivered from this location, nor shall there be any direct sales to consumers or retailers from this location.


