2 attorneys working in public interest law and primary care medical providers who serve poor  
3 communities.]

4 **Resolution urging the California State Assembly to pass AB 935, a bill that would**  
5 **provide loan repayment assistance to attorneys working in public interest law, and to**  
6 **amend AB 935 to extend debt relief to primary care medical providers who serve poor**  
7 **communities.**

9 WHEREAS, Recent law and medical school graduates often face staggering  
10 educational debt burdens that, in combination with the high cost of living in California, make it  
11 nearly economically impossible for them to choose public service careers; and

12 WHEREAS, The shortage of medical and legal professionals who work in poor and  
13 underserved communities threatens medical care and access to justice for the poor in San  
14 Francisco and across California; and

15 WHEREAS, Existing educational debt relief programs are inadequate to solve the  
16 problem, since the National Health Service Corps currently turns away two out of every three  
17 applicants and expects to turn away an even greater percentage in the future, and there are  
18 only six law schools in the country which provide sufficient debt repayment assistance for new  
19 public interest attorneys to make ends meet (only one of which is in California); and

20 WHEREAS, California State Assembly Bill 935 would supplement, not replace, existing  
21 law school loan repayment programs, and currently does not extend coverage to medical  
22 practitioners; now, therefore, be it

23 RESOLVED, That the San Francisco Board of Supervisors urges the California State  
24 Assembly to amend AB 935 to extend coverage to primary care medical providers who serve  
25 poor communities; and, be it

1           FURTHER RESOLVED, That it shall be the official position of the City and County of  
2 San Francisco to support AB 935, a bill to provide educational debt relief to public interest  
3 attorneys in California; and, be it

4           FURTHER RESOLVED, That the San Francisco Board of Supervisors directs the City's  
5 legislative lobbyist to advocate on behalf of this bill in the California State Assembly and  
6 Senate.
