### **191073 [Health Code - Medical Examiner Reports of Drug Overdose Deaths]**

**Sponsors: Haney; Walton, Ronen, Fewer and Mar**

Ordinance amending the Health Code to require the Medical Examiner to report information to the Mayor, Board of Supervisors, and Director of Health each month regarding deaths arising from drug overdoses.

**Chair Mandelman moved that this Ordinance be AMENDED, AN AMENDMENT OF THE WHOLE BEARING NEW TITLE, on Page 1, Lines 17-24, by inserting '(a) Preparation of Overdose Death Report Form. By no later than June 1, 2020, the Office of the Chief Medical Examiner shall develop a form on which any person filing a death certificate may provide information regarding whether the decedent died from causes related to overdose of drugs. The form shall seek the following information regarding each decedent: the decedent's race, ethnicity, age, and sex; the cause of death; the drug or drugs that contributed to the decedent's death; the date of death; the San Francisco neighborhood in which the decedent resided, if the decedent was a San Francisco resident; and whether the decedent was homeless.'; on Page 2, Lines 1-6, by inserting '(b) Filing of Overdose Death Report. At the time of registering a death by filing a death certificate with the Department of Public Health under Article 4 of the Health Code and California Health and Safety Code Sections 102775 et seq., the person registering or reporting the death shall also submit to the Office of the Chief Medical Examiner an Overdose Death Report in the format prescribed in subsection (a) of this Section 227. (c) Reports to Mayor, Board of Supervisors and Department of Public Health.'; on Page 2, Lines 7-8, by striking 'the 15th day of each month' and inserting 'October 15, 2020 and by the 15th day of the month every four months thereafter,'; on Page 2, Lines 10-11, by striking 'whom the Office determined in the preceding calendar month to have' and inserting 'who were reported to have'; on Page 2, Lines 11-12, by inserting 'in Overdose Death Reports that the Office of the Chief Medical Examiner received in the preceding four months.'; on Page 2, Lines 14-15, by inserting 'in aggregate form, divided by calendar month'; on Page 2, Line 18, by striking 'the decedent was a San Francisco resident' and inserting 'known'; and making other conforming, clarifying, and clerical changes.
