9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby

12 and County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-24-  
13 611594, by the payment of \$300,000. The lawsuit involves a claim for refund of transfer  
14 taxes, penalties, and interest.
