2 URGING CATHOLIC HEALTHCARE WEST TO ABIDE BY THE AGREEMENTS REACHED
3 WITH SEIU LOCAL 250 ON AUGUST 13, 2000

4 WHEREAS, the Service Employees International Union Local 250 has been in
5 negotiations with St. Francis Memorial Hospital, St. Mary's Medical Center and Seton Medical
6 Center, all operated by Catholic Healthcare West; and

7 WHEREAS, there have been two major hospital strikes and six months of negotiations
8 between the three CHW hospitals and their 1,600 employees; and

9 WHEREAS, on August 13, 2000, a tentative agreement was reached between Local
10 250, and Harry Joel, Vice President of Human Resources for Catholic Healthcare West,
11 resulting in major improvements for workers and for the quality of patient care in Bay Area
12 hospitals; and

13 WHEREAS, these agreements would give caregivers a real voice in patient care
14 issues, as well as, protect an employee's right to choose a union without interference; and

15 WHEREAS, on August 18, 2000, the leadership of Catholic Healthcare West
16 repudiated the agreement

17 WHEREAS, the Board of Supervisors and the people of the City and County of San
18 Francisco have an interest in the quality of health care available at these critical medical
19 institutions; and

20 WHEREAS, the issues of staffing and labor peace contribute to that quality of care;
21 now, therefore, be it

22 RESOLVED, that the Board of Supervisors urges Catholic Healthcare West to abide by
23 the agreements reached with SEIU Local 250 on August 13, 2000.


