RESOLVED, That pursuant to Administrative Code, Section 10.22, the Board of Supervisors hereby authorizes the City Attorney to settle and compromise the claim by payment of \$70,000 and agreement by Dunbar to resign and not seek or accept future employment with the SFPD.
