
13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. The City Attorney is hereby authorized to settle the court action entitled  
15 Morgan Stanley Dean Witter & Co. Inc., et. al. v. City and County of San Francisco, San  
16 Francisco Superior Court No. 322-341 by payment of a total amount not to exceed  
17 \$1,200,000.00. The settlements shall include any claims for the 2000 tax year, and plaintiffs  
18 shall agree not to file any claims for refunds otherwise due pursuant to Section 1021 of Article  
19 12B of the San Francisco Business and Tax Regulations Code. Plaintiffs may file timely  
20 refund claims for tax credits with regard to year 2000 payroll taxes pursuant to Sections 906  
21 through 906E of Article 12B of the San Francisco Business and Tax Regulations Code. These  
22 claims, if any, will be processed by the City on their own merits.

23 Section 2. The Morgan Stanley lawsuit was filed in San Francisco Superior Court on  
24 June 22, 2001, and the following parties were named in the lawsuit: Morgan Stanley Dean  
25 Witter & Co. Inc., a Delaware Corporation, Morgan Stanley & Co. Inc., a Delaware

1 Corporation, Morgan Stanley DW Inc., a Delaware Corporation, and Morgan Stanley Realty  
2 Inc., a Delaware Corporation, as plaintiffs and the City and County of San Francisco, as  
3 defendant.




