3 **Resolution authorizing the Department of the District Attorney of the City and County**
4 **of San Francisco to accept and expend a grant in the amount of \$25,000 through the**
5 **Blue Shield of California Foundation, for a project entitled "Planning Grant for**
6 **Comprehensive Services to Children Who Witness Violence" for the period March 1,**
7 **2007 to December 1, 2007.**

9 WHEREAS, The City and County of San Francisco is committed to a planning process
10 for comprehensive services to children who witness violence; and,

11 WHEREAS, District Attorney Kamala D. Harris worked to secure grant funds for this
12 purpose through the Blue Shield of California Foundation; and,

13 WHEREAS, The Department proposes to maximize use of available grant funds on
14 program expenditures by not including indirect costs in the grant budget; and,

15 WHEREAS, The grant does not require an ASO amendment, and,

16 WHEREAS, there is no match requirement for this grant; now, therefore, be it

17 **RESOLVED, That the Board of Supervisors hereby authorizes the District Attorney of**
18 **the City and County of San Francisco to accept and expend funds from Blue Shield of**
19 **California Foundation for planning for comprehensive services for children who witness**
20 **violence; and be it**

21 **FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of**
22 **indirect costs in the grant budget; and be it**


23 **FURTHER RESOLVED, That the District Attorney is authorized to execute on behalf of**
24 **the City and County of San Francisco the necessary Grant Award Agreements for this project,**
25 **including any extensions, augmentations or amendments thereof; and be it**

1 FURTHER RESOLVED, That the District Attorney is authorized and empowered to
2 execute, deliver and perform, in the name of the City and County of San Francisco, all
3 applications, contracts, agreements, amendments and payment requests necessary for the
4 purpose of securing these grant funds and to implement and carry out the purposes specified
5 in the applicable grant application; and be it


6 FURTHER RESOLVED, That any liability arising out of the performance of the Grant
7 Award Agreement, including civil court actions for damages, shall be the responsibility of the
8 grant recipient and the authorizing agency; and that the grant recipient and the authorizing
9 agency will hold Blue Shield of California Foundation harmless from any claims that may arise
10 from the use of grant funds; be it

11 FURTHER RESOLVED, That grant funds received hereunder shall not be used to
12 supplant expenditures controlled by this body.
