WHEREAS, On November 4, 2020, the Department of Public Health (DPH) issued a Request for Proposals (RFP No. 39-2020) for HIV health services rental subsidies services; and

WHEREAS, Catholic Charities submitted a proposal and was the highest ranked applicant; and

WHEREAS, DPH awarded the contract to Catholic Charities; and

WHEREAS, On July 1, 2021, DPH and Catholic Charities entered into an agreement for HIV health services rental subsidies services ("Original Agreement"); and

WHEREAS, The Original Agreement has a term of July 1, 2021, through June 30, 2026, and a not to exceed amount of \$6,109,208; and

WHEREAS, DPH wishes to amend the agreement by extending the term to June 30, 2031, and increasing the maximum expenditure by \$7,317,206 to \$13,426,414 (the "First Amendment"); and

WHEREAS, Charter, Section 9.118(b) requires Board of Supervisors' approval by Resolution of any contract which, when entered into, extends over 10 years, and of any contract which, when entered into, costs the City \$10,000,000 or more; and

WHEREAS, The proposed amendment contained in File No. 251049, is substantially in final form, with all material terms and conditions included, and only remains to be executed by the parties upon approval of this Resolution; now, therefore, be it

RESOLVED, That the Board of Supervisors hereby approves the amendment in substantially the form contained in File No. 251049; and, be it

FURTHER RESOLVED, That the Board of Supervisors authorizes DPH to make any modifications to the amendment, prior to its final execution by all parties, that DPH determines, in consultation with the City Attorney, are consistent with this Resolution, in the best interest of the City, do not materially increase the obligations or liabilities of the City, are necessary or advisable to effectuate the purposes of the amendment, and are in compliance with all applicable laws, including City's Charter; and, be it

FURTHER RESOLVED, That within 30 days of the amendment being fully executed by all parties, DPH shall submit to the Clerk of the Board of Supervisors a completely executed copy for inclusion in File No. 251049; this requirement and obligation resides with the Department, and is for purposes of having a complete file only, and in no manner affects the validity of approved amendment.
