11 WHEREAS, The City Planning Department has verified that the area is properly  
12 zoned; and,

13 WHEREAS, The Police Department recommends that the liquor license  
14 application be approved with conditions; now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business  
16 and Professions Code, the Board of Supervisors of the City and County of San  
17 Francisco hereby determines for the foregoing reasons that the transfer of a Type 20  
18 off-sale beer and wine license from 3699 17<sup>th</sup> Street to 2339 Third Street, Suite 19 for  
19 Jason Walthall for Taste Inc., will serve the public convenience and necessity of the  
20 people of the City and County of San Francisco.

21 Conditions: (1) Sales of alcoholic beverages shall be permitted only between the  
22 hours of 9:00 a.m. to 6:00 p.m. daily; (2) The off-sale beer and wine license shall be  
23 restricted to sales solicited and accepted by direct mail, telephone, or on-line computer.  
24 The off-sale beer and wine license shall not be used for operations conducted from a  
25 retail store open to the public.


