11 Erica Craven, succeeding herself, term expiring April 27, 2006, seat 1, must be  
12 appointed from names submitted by the local chapter of the Society of Professional  
13 Journalists and be an Attorney, for a two-year term ending April 27, 2008.

14 Richard Knee, succeeding himself, term expiring April 27, 2006, seat 2, must be  
15 appointed from names submitted by the local chapter of the Society of Professional  
16 Journalists and be a journalist, for a two-year term ending April 27, 2008.

17 Sue Cauthen, succeeding herself, term expiring April 27, 2006, seat 3, must be a  
18 member of the press or electronic media with an interest in citizen access, for a two-year term  
19 ending April 27, 2008.

20 Kristin R. M. Chu, succeeding herself, term expired, seat 5, must be appointed from  
21 names submitted by the League of Women Voters, for a two-year term ending April 27, 2008.

22 David Pilpel, succeeding himself, term expiring April 27, 2006, seat 7, must be  
23 experienced in Consumer Advocacy, for a two-year term ending April 27, 2008.

24 Bruce Wolfe, succeeding himself, term expiring April 27, 2006, seat 8, must be a  
25 member of the public who has demonstrated interest in or has experience in the issues of

1 citizen access and participation in local government, for a two-year term ending April 27,  
2 2008.

3 Hanley Chan, succeeding himself, term expiring April 27, 2006, seat 9, must be a  
4 member of the public who has demonstrated interest in or has experience in the issues of  
5 citizen access and participation in local government, for a two-year term ending April 27,  
6 2008.
