WHEREAS, on September 7, 2000, the Planning Commission reviewed and considered the FEIR and, by Motion No. 15974 found that the contents of said report and the procedures through which the FEIR was prepared, publicized and reviewed complied with the provisions of the California Environmental Quality Act ("CEQA") and the CEQA Guidelines and Chapter 31 of the San Francisco Administrative Code; and

WHEREAS, by Motion No. 15974 the Planning Commission found that the FEIR was adequate, accurate and objective, reflected the independent judgment of the Commission and

that the summary of Comments and Responses contained no significant revisions to the draft Environmental Impact Report, adopted findings of significant impacts associated with the Project and certified the completion of the FEIR for the Project in compliance with CEQA and the CEQA Guidelines; and

WHEREAS, the Planning Commission's certification of the FEIR has been appealed to this Board; and

WHEREAS, the FEIR files and other Project-related Department files have been available for review by this Board of Supervisors and the public, and those files are part of the record before this Board of Supervisors; and

WHEREAS, this Board has reviewed and considered the FEIR, and heard testimony and received public comment regarding the adequacy of the FEIR; NOW, THEREFORE,

BE IT MOVED, That this Board affirms the certification of the FEIR by the Planning Commission and finds that that the contents of the FEIR and the procedures through which the FEIR was prepared, publicized and reviewed complies with the provisions of CEQA and the CEQA Guidelines and Chapter 31 of the San Francisco Administrative Code; and be it

FURTHER MOVED, That this Board finds that the FEIR is adequate, accurate and objective, reflects the independent judgment and analysis of this Board and that the summary of Comments and Responses contains no significant revisions to the draft Environmental Impact Report; and be it
