Dear Committee Members,

Never in my sixty-four (64) years of living would I have imagined that the District Attorney's office would be considered for budget cuts. I am a resident of the Tenderloin and a fifth generational San Franciscan and today I have the pleasure of addressing this Committee in an attempt to be heard in the hopes of reminding everyone that we still have much left to do in terms of law enforcement which should be on the minds of everyone every day. How do we make our city safe when the gladly support the ever-increasing police department overtime (which more than doubled from the previous two (2) years) but seek to cut the budget of the Chief Law Enforcement officer in San Francisco? The previous District Attorney was recalled for a lack of prosecution and the current District Attorney is doing exactly what we wanted to see and not only are the prosecution numbers up by for the first time in a long time, but we can also see a difference on the streets. Each of you is involved in dialogue within your respective districts to continue the improvements being seen. Cutting the budget of the District Attorney's office has serious and significant repercussions and will (without doubt) cause a ripple effect within a city that is seeking to recover not simply from Covid but the empty coffees which we usually have from tourism.

From the moment of arrest, there is a clock ticking and counting down and unless someone waives time, that clock does not care if there is one (1) tourist or one hundred thousand (100,000) tourists in our city. Reviewing courts are not concerned that we are nearly broke they want to know if the rules were followed. The Public Defender or even our Judges don't check to see if the District Attorney's office is over budget or does not have the funds to prosecute a case. Sure, it would be nice to see less crime and leaner times but right now that is not practical. I have witnessed (firsthand) how creative the Public Defender has become in defending those charged with drug sales and the 'expert witnesses' being utilized by that office. Defendants have rights and I get that. As a citizen, I too have rights and the first order of business in any government should be the safety of its citizens.

Cutting the budget of the District Attorney is tantamount to telling your constituents that you don't care about their safety and that we can't afford to keep us safe! We have some very good ideas coming from various sources on how to make improvements in the hopes we bring back the visitors to our city. We saw a decrease in revenues when we lost the AMA and their annual conference because nobody believed they would actually walk. Well, they did and now Las Vegas is seeing revenue we did not have to lose. We knew if the wrong decision but did it anyway and look at where we are today. What are we doing to keep merchants like CVS and Walgreens from abandoning our city? I'm not going to purchase products from Amazon because it does not solve our long-term problems. If we don't remember the past – we are destined to repeat it.

The leanest operation here in San Francisco is the District Attorney's office. They compete for quality staff like the police department, and we are down on those numbers (still). I challenge this committee to find the reason we are hemorrhaging exceedingly increasing overtime within the police department. I will not mention or even remind each of you that there was supposed to be an investigation into theft/misuse of police department funds by Kyra Worthy (and a non-profit organization) who thought it was okay to leave employees without unemployment benefits or a final paycheck. My sister was a victim of that fiasco!

It is my considered opinion that if the funding to the District Attorney's office is cut (regardless to the amount) you will be turning back the hands of time in San Francisco by several years. The difference will be recognized immediately but this time I don't see any possible chance of taxpayer support moving forward and while I will not speak for anyone other than myself, I will not hang around to see the effects when the _hit hits the fan. I will take my retirement package and leave San Francisco. No doubts in my mind. I love my city, but I am not willing to die because of careless mistakes caused by politicians and politics!

I will end this letter by reminding each of you of the following: "Local governments have a significant responsibility to their citizens to provide public safety. This includes maintaining law enforcement, providing emergency services, and implementing safety programs. Local governments also play a crucial role in ensuring the safety and well-being of their communities by maintaining public spaces, enforcing building codes and promoting public health initiatives." In essence, local governments are accountable to their citizens for providing a safe and secure environment where people can live, work and enjoy their daily lives.

The above appears as a matter of record for your further discussion and disposition on the referenced subject matter. The author of this document does not endorse, nor does he support any cut whatsoever to the budget of the Office of the District Attorney for the County of San Francisco.

Hi Brent,

I **strongly oppose** the request by District Attorney Jenkins for increased funding for her office! I demand to see justification for how arresting 25% more San Franciscans will somehow lead to increased safety.

The D.A. is using Prop 36 and the Racial Justice Act as excuses to ask for more funding for an already well funded office. By comparison, the Public Defender's office budget is only 60% of the District Attorney's office which speaks to skewed priorities in implementing justice in San Francisco. The main threat to implementing due process in S.F. lies in the underfunding of the Public Defender's office. The D.A. is using the Racial Justice Act to demand more funding but other D.A.'s offices around the state have been able to figure out how to implement race blind charging without the millions of dollars of funding increases that D.A. Jenkins is requesting. Prop 36 gives DA's discretion as to whether to charge offenses as felonies, which further strains the very overcrowded SF County jail system as well as the court system. The DA's office could be prioritizing public safety through treatment and service options which are available. Instead of seeking additional funding, D.A. Jenkins needs to shift her across the board commitment to overcharging and the inflated resources that requires.

Dear Members of the Budget and Appropriations Committee,

I write on behalf of the Lawyers' Committee for Civil Rights of the San Francisco Bay Area to express our strong opposition to the District Attorney's request for \$19.8 million in additional funding. At a time when our city faces a historic budget crisis, with critical programs for housing, domestic violence prevention, and public health on the chopping block, the city must exercise fiscal responsibility instead of funding unchecked carceral expansion.

The DA's request is based on speculative arrest projections, anticipating a 25% increase in arrests, rather than clear public safety outcomes. Meanwhile, the Public Defender's Office continues to operate with only 60% of the DA's budget, undermining due process and fairness in our legal system. Community-based alternatives that actually promote safety such as pretrial diversion, treatment programs, and restorative justice remain woefully underfunded and underutilized. This imbalance reveals a troubling prioritization of punishment over prevention.

The DA's office has attempted to justify this expansion by misusing Race Blind Charging and the Racial Justice Act (RJA). Yet other counties have successfully implemented these policies without multimillion-dollar budget increases. The real issue is not a lack of resources, but a refusal to shift away from overcharging, excessive incarceration, and reliance on inflated tech contracts. Prop 36, for example, gives the DA discretion to charge offenses as felonies—a practice that exacerbates overcrowding in our jails and strains the court system. Rather than

seeking more funding, the DA should be prioritizing treatment and services that address root causes of harm.

People of color are disproportionately ensnared within the criminal legal system. In San Francisco, the per capita incarceration rate of Black people is over seventeen times that of white people. The city has a history of vast disparities in arrest, incarceration, and conviction rates of Black residents. Remedying racial disparities requires better funding of the Public Defender's office, whose clients are overwhelmingly people of color, and investment in community-based networks of care, not reviving failed tough-on-crime approaches.

San Francisco must embrace fiscal responsibility and equity in this moment of crisis. We urge you to:

- Reject the DA's \$19.8 million request, which would deepen our reliance on failed carceral approaches.
- Demand transparency and outcomes tracking from the DA's office to ensure existing funds are used effectively.
- Redirect resources to programs that stabilize our communities such as affordable housing, mental health services, and violence prevention rather than punishing them.

This is a pivotal moment to demand **balanced justice**, not unchecked carceral growth. The Board must stand with San Franciscans who believe in a safer, more equitable future that invests in people, not prisons.

Good afternoon, Supervisors.

At a time of rising authoritarianism in the US it makes no sense to single out the DA's office as deserving of a budget increase when equally critical city departments are all tightening their belts in preparation for the next FY and while San Franciscans are making enormous sacrifices and living in fear of a federal clampdown.

Across the country, we're watching corrupt Trump officials like Kristi Noem who came to SF last week —undermine civil rights, criminalizing dissent, and targeting immigrants, trans people, unhoused residents, and communities of color for private for profit detention centers. The last thing San Francisco should do is expand prosecutorial power that can be used to mirror these corrupt and authoritarian tactics.

At a time when crime in our city is at a historic low, we should have a more thoughtful approach balanced across our public safety departments and with all of the city's priorities. Why consider inflating the budget of an office already mired in ethical violations, public attacks on the judiciary, and quiet collaboration with ICE and federal prosecutors? This is not justice—it's capitulation and complicity.

Let's not forget: the City of St Francis has long aspired to be a beacon of compassion and protection for the most vulnerable. We should be protecting due process and civil liberties, not undermining them with more resources to entangle people in a corrupt and dystopian justice system on par with Benito Mussolini's version of Italy.

We must resist fear-based policymaking and invest instead in what truly keeps us safe—housing, mental health care, youth development, and restorative practices.

As maga extremists threaten federal judges who uphold the rule of law, a DA's office that aligns itself with authoritarian rhetoric—claiming judges are "too lenient," sidestepping sanctuary protections, and inflaming public fear—does not deserve more power. It needs more oversight.

Budgets are moral documents. Let ours say clearly: we will not fund fear, we will not fund oppression, and we will not let San Francisco drift toward authoritarianism.
