16 Alcoholic Beverage Control issue the liquor license with no additional conditions; now,  
17 therefore, be it

18 RESOLVED, That in accordance with California Business and Professions Code,  
19 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
20 hereby determines that the transfer of a Type-48 on-sale general public premises liquor  
21 license to Buzzworks Inc., doing business as Buzzworks at 365-11th Street, will serve  
22 the public convenience or necessity of the City and County of San Francisco.
