3 **Ordinance amending the San Francisco Planning Code by amending Section 409 to**  
4 **clarify that the Annual Infrastructure Cost Inflation Adjustments to development fees**  
5 **authorized by the section do not need further action by the Board of Supervisors, to**  
6 **provide that the Planning Director be included in the annual fee reporting process, and**  
7 **to make other technical amendments to simplify the annual fee reporting process and**  
8 **ensure that the Controller's Office and the Capital Planning Program coordinate their**  
9 **efforts, and by amending other sections of Article 4 to clarify language, eliminate**  
10 **confusion as to when requirements must be met, and correct errors in cross-**  
11 **referencing; amending the San Francisco Administrative Code by repealing Section**  
12 **38.14 (the Severability Clause) and moving it to Section 430; adopting environmental,**  
13 **Planning Code Section 302, and Planning Code Section 101.1 findings.**

17 Be it ordained by the People of the City and County of San Francisco:

18 Section 1. Findings. The Board of Supervisors hereby finds that:

19 (1) The Planning Department has determined that the actions contemplated in this  
20 ordinance comply with the California Environmental Quality Act (California Public Resources  
21 Code Section 21000 et seq.). Said determination is on file with the Clerk of the Board of  
22 Supervisors in File No. \_\_\_\_\_ and is incorporated herein by reference.

23 (2) Pursuant to Section 302 of the Planning Code, the Board finds that this  
24 ordinance will serve the public necessity, convenience, and welfare for the reasons set forth in  
25 Planning Commission Resolution No. \_\_\_\_\_ and the Board incorporates such reasons

1 herein by reference. A copy of Planning Commission Resolution No. \_\_\_\_\_ is on file with  
2 the Clerk of the Board of Supervisors in File No. \_\_\_\_\_.

3 (3) This ordinance is in conformity with the General Plan and the Priority Policies of  
4 Planning Code Section 101.1 for the reasons set forth n Planning Commission Resolution No.  
5 \_\_\_\_\_ and the Board incorporates such reasons herein by reference.

6 Section 2. The San Francisco Planning Code is hereby amended by amending  
7 Sections 402, 403, 409, 411.3, 411.4, 412.4, 413.4, 4.14.4, 414.10, 414.15, 416.3, 417.4,  
8 418.4, 419.2, 419.3, 419.4, 419.5, 420, 420.4, 420.5, 421.4, 422.4, 423.4, 424.3, and adding  
9 Section 430, to read as follows:

10 **SEC. 402. PROCEDURE FOR PAYMENT AND COLLECTION OF DEVELOPMENT**  
11 **FEES.**

12 (a) **Collection by the Development Fee Collection Unit.** All development impact  
13 and in-lieu fees authorized by this Code shall be collected by the Development Fee Collection  
14 Unit at DBI in accordance with Section 107A.13 of the San Francisco Building Code.

15 (b) **Required ~~City Agency or~~ Department Notice to Development Fee Collection**  
16 **Unit.** Prior to Issuance of Building or Site Permit; Request to Record Notice of Fee.

17 (1) **Required Notice.** When the Planning Department determines that a  
18 development project is subject to one or more development fees or development impact  
19 requirements, but in any case no later than prior to issuance of the building or site permit for a  
20 development project, the Department shall send written or electronic notification to the  
21 Development Fee Collection Unit at DBI, and also to MOH, MTA or other applicable agency  
22 that administers an applicable development fee or development impact requirement, that: (i)  
23 identifies the development project, (ii) lists which specific development fees and/or  
24 development impact requirements are applicable and the legal authorization for their  
25 application, (iii) specifies the dollar amount of the development fee or fees that the

1 Department calculates is owed to the City or that the project sponsor has elected to satisfy a  
2 development impact requirement through the provision of physical or "in-kind" improvements,  
3 and (iv) lists the name and contact information for the staff person at each agency or  
4 department responsible for calculating the development fee or monitoring compliance with the  
5 development impact requirement for physical or in-kind improvements.

6 (2) **Amended Notices.** The Department shall send an amended notice to the  
7 Development Fee Collection Unit, and also to any department or agency that received the  
8 initial notice, if at any time subsequent to its initial notice: (i) any of the information required by  
9 subsection (1) above is changed or modified, or (ii) the development project is modified by the  
10 Department or Commission during its review of the project and the modifications change the  
11 dollar amount of the development fee or the scope of any development impact requirement.

12 (3) **Optional Recordation of Notice of Special Restrictions Prior to Issuance of**  
13 **Building or Site Permit.** Prior to issuance of a building or site permit for a development  
14 project subject to a development fee or development impact requirement, the Department  
15 may request the Development Fee Collection Unit to record a notice with the County Recorder  
16 that a development project is subject to a development fee or development impact  
17 requirement. The County Recorder shall serve or mail a copy of such notice to the persons  
18 liable for payment of the fee or satisfaction of the requirement and the owners of the real  
19 property described in the notice. The notice shall include (i) a description of the real property  
20 subject to the development fee or development impact requirement, (ii) a statement that the  
21 development project is subject to the imposition of the development fee or development  
22 impact requirement, and (iii) a statement that the dollar amount of the fee or the specific  
23 development impact requirement to which the project is subject has been determined under  
24 Article 4 of this Code and citing the applicable section number.

1 (c) **Process for Revisions of Determination of Development Impact Fee(s) or**  
2 **Development Impact Requirement(s).** In the event that the Department or the Commission  
3 takes action affecting any development project subject to this Article and such action is  
4 subsequently modified, superseded, vacated, or reversed by the Board of Appeals, the Board  
5 of Supervisors, or by court action, the building permit or building permit application for such  
6 development project shall be remanded to the Department to determine whether the  
7 development project has been changed in a manner which affects the calculation of the  
8 amount of development fees or development impact requirements required under this Article  
9 and, if so, the Department shall revise the requirement imposed on the permit application in  
10 compliance with this Article within 30 days of such remand and notify the project sponsor in  
11 writing of such revision or that a revision is not required. The Department shall notify the  
12 Development Fee Collection Unit at DBI if the revision materially affects the development fee  
13 requirements originally imposed under this Article so that the Development Fee Collection  
14 Unit update the Project Development Fee Report and re-issue the associated building or site  
15 permit for the project, if necessary, to ensure that any revised development fees or  
16 development impact requirements are enforced.

17 **SEC. 403. PAYMENT OF DEVELOPMENT FEE(S) OR SATISFACTION OF**  
18 **DEVELOPMENT IMPACT REQUIREMENT(S) AS A CONDITION OF APPROVAL ~~FOR~~**  
19 **~~ISSUANCE OF BUILDING OR SITE PERMIT~~; PLANNING COMMISSION REVIEW;**  
20 **RECOMMENDATION CONCERNING EFFECTIVENESS OF FEE DEFERRAL PROGRAM.**

21 (a) **Condition of Approval.** In addition to any other condition of approval that may  
22 otherwise be applicable, the Department or Commission shall require as a condition of  
23 approval of *any building or site permit for* a development project subject to a development fee  
24 or development impact requirement under this Article that such development fee or fees be  
25 paid prior to the issuance of the first construction document for the development project, with

1 an option for the project sponsor to defer payment of 85 percent of the fees, or 80 percent of  
2 the fees if the project is subject to a neighborhood infrastructure impact development fee, to  
3 prior to issuance of the first certificate of occupancy upon agreeing to pay a Development Fee  
4 Deferral Surcharge on the amount owed, as provided by Section 107A.13.3 of the San  
5 Francisco Building Code ("Fee Deferral Program"). The Department or Commission shall also  
6 require as a condition of approval that any development impact requirement imposed on a  
7 development project under this Article shall be satisfied prior to issuance of the first certificate  
8 of occupancy for the development project.

9 (b) **Hearing to Review Effectiveness of Fee Deferral Program.** Under 107A.13.3  
10 of the San Francisco Building Code, the option to defer the payment of development fees  
11 expires on July 1, 2013 unless the Board of Supervisors extends the Fee Deferral Program.  
12 Prior to the July 1, 2013 expiration date, the Planning Commission shall hold a public hearing  
13 to review the effectiveness of the Fee Deferral Program, the economy at large, and whether  
14 the stimulative effects of the Fee Deferral Program are still necessary. Following the public  
15 hearing, the Commission shall forward a recommendation to the Board of Supervisors as to  
16 whether the Fee Deferral Program should be continued, modified, or terminated.

17 **SEC. 409. ANNUAL CITYWIDE DEVELOPMENT FEE REPORTING**  
18 **REQUIREMENTS.**

19 (a) **Annual Citywide Development Fee and Development Impact Requirements**  
20 **Report.** In coordination with the Development Fee Collection Unit at DBI *and the Planning*  
21 *Director*, the Controller shall issue a report within 180 days after the end of each fiscal year,  
22 that provides information on all development fees collected during the prior fiscal year  
23 organized by development fee account and all cumulative monies collected over the life of  
24 each development fee account, as well as all monies expended. The report shall also provide  
25 information on the number of projects that elected to satisfy development impact requirements

1 through the provision of "in-kind" physical improvements, including on-site and off-site BMR  
2 units, instead of paying development fees. The report shall also include any annual reporting  
3 information otherwise required pursuant to the California Mitigation Fee Act, Government  
4 Code 66001 et seq. The report shall be presented by the Planning Director to the Planning  
5 Commission and to the Land Use & Economic Development Committee of the Board of  
6 Supervisors. The Report shall also contain ~~recommendations for~~ information on the Controller's  
7 annual construction cost inflation adjustments to development fees, described in subsection  
8 (b) below.

9 (b) **Annual Development Fee Infrastructure Construction Cost Inflation**

10 **Adjustments.** ~~In conjunction with~~ Prior to issuance of the Annual Citywide Development Fee  
11 and Development Impact Requirements Report referenced in subsection (a) above, the  
12 Controller shall review the amount of each development fee established in this Article and  
13 shall adjust the dollar amount of any development fee on an annual basis every January based  
14 solely on the Annual Infrastructure Construction Cost Inflation Estimate published by the Office  
15 of the City Administrator's Capital Planning Group and approved by the City's Capital Planning  
16 Committee no later than December 1 every year, without further action by the Board of Supervisors.  
17 The Annual Infrastructure Construction Cost Inflation Estimate shall be updated by the Capital  
18 Planning Group on an annual basis and no later December 1 every year, in consultation with the  
19 Capital Planning Committee, ~~with the goal of~~ in order to ~~establishing~~ a reasonable estimate of  
20 construction cost inflation for the next ~~fiscal~~ calendar year for a mix of public infrastructure and  
21 facilities in San Francisco. The Capital Planning Group may rely on past construction cost  
22 inflation data, market trends and a variety of national, state and local commercial and  
23 institutional construction cost inflation indices in developing their annual estimates for San  
24 Francisco. The Planning Department and the Development Fee Collection Unit at DBI shall  
25 provide notice of ~~any~~ the Controller's proposed development fee adjustments, including the

1 Annual Infrastructure Construction Cost Inflation Estimate formula used to calculate the  
2 adjustment, on ~~its~~ the Planning Department and DBI website and to any interested party who  
3 has requested such notice at least 30 days prior to the adjustment taking effect each January.

4 **SEC. 411.3. APPLICATION OF TIDF.**

5 (a) **Application.** Except as provided in Subsections (1) and (2) below, the TIDF  
6 shall be payable with respect to any new development in the City for which a building or site  
7 permit is issued on or after September 4, 2004. In reviewing whether a development project is  
8 subject to the TIDF, the project shall be considered in its entirety. A sponsor shall not seek  
9 multiple applications for building permits to evade paying the TIDF for a single development  
10 project.

11 (1) The TIDF shall not be payable on new development, or any portion thereof, for  
12 which a TIDF has been paid, in full or in part, under the prior TIDF Ordinance adopted in 1981  
13 (Ordinance No. 224-81; former Chapter 38 of the Administrative Code), except where (A)  
14 gross square feet of use is being added to the building; or (B) the TIDF rate for the new  
15 development is in an economic activity category with a higher fee rate than the rate set for  
16 MIPS, as set forth in Section 411.3(e).

17 (2) No TIDF shall be payable on the following types of new development.

18 (A) New development on property owned (including beneficially owned) by the City,  
19 except for that portion of the new development that may be developed by a private sponsor  
20 and not intended to be occupied by the City or other agency or entity exempted under Section  
21 411.1 et seq., in which case the TIDF shall apply only to such non-exempted portion. New  
22 development on property owned by a private person or entity and leased to the City shall be  
23 subject to the fee, unless the City is the beneficial owner of such new development or unless  
24 such new development is otherwise exempted under this Section.

1 (B) Any new development in Mission Bay North or South to the extent application of  
2 this Chapter would be inconsistent with the Mission Bay North Redevelopment Plan and  
3 Interagency Cooperation Agreement or the Mission Bay South Redevelopment Plan and  
4 Interagency Cooperation Agreement, as applicable.

5 (C) New development located on property owned by the United States or any of its  
6 agencies to be used exclusively for governmental purposes.

7 (D) New development located on property owned by the State of California or any of  
8 its agencies to be used exclusively for governmental purposes.

9 (E) New development for which a project sponsor filed an application for  
10 environmental evaluation or a categorical exemption prior to April 1, 2004, and for which the  
11 City issued a building permit or site permit on or before September 4, 2008; provided  
12 however, that such new development may be subject to the TIDF imposed by Ordinance No.  
13 224-81, as amended through June 30, 2004, except that the Department and the  
14 Development Fee Collection Unit at DBI shall be responsible for the administration,  
15 imposition, review and collection of any such fee consistent with the administrative procedures  
16 set forth in Section 411.1 et seq. The Department shall make the text of Ordinance No. 224-  
17 81, as amended through June 30, 2004, available on the Department's website and shall  
18 provide copies of that ordinance upon request.

19 (F) The following types of new developments:

20 (i) Public facilities/utilities, as defined in Section 209.6 of this Code;

21 (ii) Open recreation/horticulture, as defined in Section 209.5 of this Code, including  
22 private noncommercial recreation open use, as referred to in Section 221(g) of this Code;

23 (iii) Vehicle storage and access, as defined in Section 209.7 of this Code;

24 (iv) Automotive services, as defined in Section 223(l)-(v) of this Code, that are in a  
25 new development;



1 (v) Wholesale storage of materials and equipment, as defined in Section 225 of this  
2 Code;

3 (vi) Other Uses, as defined in Section 227(a)—(q) and (s)—(t) of this Code;

4 (b) **Timing of Payment.** Except for those Integrated PDR projects subject to  
5 Section 328 of this Code, the TIDF shall be paid prior to issuance of the first construction  
6 document, with an option for the project sponsor to defer payment until prior to issuance of the  
7 first certificate of occupancy upon agreeing to pay a deferral surcharge in accordance with  
8 Section 107A.13 of the San Francisco Building Code. Under no circumstances may any City  
9 official or agency, including the Port of San Francisco, issue a certificate of final completion  
10 and occupancy for any new development subject to the TIDF until the TIDF has been paid;

11 (c) **Calculation of TIDF.** The TIDF shall be calculated on the basis of the number of  
12 square feet of new development, multiplied by the square foot rate in effect at the time of  
13 building or site permit issuance for each of the applicable economic activity categories within  
14 the new development, as provided in Subsection 411.3(e) below. An accessory use shall be  
15 charged at the same rate as the underlying use to which it is accessory. Whenever any new  
16 development or series of new developments cumulatively creates more than 3,000 gross  
17 square feet of covered use within a structure, the TIDF shall be imposed on every square foot  
18 of such covered use (including any portion that was part of prior new development below the  
19 3,000 square foot threshold).

20 (d) **Credits.** In determining the number of gross square feet of use to which the  
21 TIDF applies, the Department shall provide a credit for prior uses eliminated on the site. The  
22 credit shall be calculated according to the following formula:

23 (1) There shall be a credit for the number of gross square feet of use being  
24 eliminated by the new development, multiplied by an adjustment factor to reflect the difference  
25

1 in the fee rate of the use being added and the use being eliminated. The adjustment factor  
2 shall be determined by the Department as follows:

3 (A) The adjustment factor shall be a fraction, the numerator of which shall be the fee  
4 rate which the Department shall determine, in consultation with the MTA, if necessary, applies  
5 to the economic activity category in the most recent calculation of the TIDF Schedule  
6 approved by the MTA Board for the prior use being eliminated by the project.

7 (B) The denominator of the fraction shall be the fee rate for the use being added, as  
8 set forth in the most recent calculation of the TIDF Schedule approved by the MTA Board.

9 (2) A credit for a prior use may be given only if the prior use was active on the site  
10 within five years before the date of the application for a building or site permit for the proposed  
11 use.

12 (3) As of September 4, 2004, no sponsor shall be entitled to a refund of the TIDF on  
13 a building for which the fee was paid under the former Chapter 38 of the San Francisco  
14 Administrative Code.

15 (4) Notwithstanding the foregoing, the adjustment factor shall not exceed one.

16 (e) **TIDF Schedule.**

17 ~~(f)~~ The TIDF Schedule shall be as follows:

1           (2) — ~~Biennial Adjustment. Biennially, beginning July 1, 2005, the TIDF Schedule shall be~~  
2 ~~adjusted, without further action by the Board of Supervisors, to reflect the average annual change in~~  
3 ~~the San Francisco Bay Area Consumer Price Index (CPI) for "All Urban Consumers" for the prior two~~  
4 ~~years, as reported by the Association of Bay Area Governments, and as determined by the Director of~~  
5 ~~MTA.~~

6           **SEC. 411.4. IMPOSITION OF TIDF.**

7           (a)     **Determination of Requirements.** The Department shall determine the  
8 applicability of Section 411.1 et seq. to any development project requiring a first construction  
9 document ~~building or site permit~~ and, if Section 411.1 is applicable, shall impose any TIDF owed  
10 as a condition of approval for issuance of the first construction document ~~building or site permit~~  
11 for the development project. The project sponsor shall supply any information necessary to  
12 assist the Department in this determination. The Zoning Administrator may seek the advice  
13 and consent of the MTA regarding any interpretations that may affect implementation of this  
14 section.

15           (b)     Department **Notice to Development Fee Collection Unit at DBI and MTA of**  
16 **Requirements.** After the Department has made its final determination regarding the  
17 application of the TIDF to a development project under Section 411.1 et seq., it shall  
18 immediately notify the Development Fee Collection Unit at DBI and the Director of MTA of any  
19 TIDF owed in addition to the other information required by Section 402(b) of this Article. If the  
20 MTA Director disputes the Department's calculation, he or she shall promptly inform the  
21 Development Fee Collection Unit and the MTA Director's determination shall prevail.

22           (c)     **Process for Revisions of Determination of Requirements.** In the event that  
23 the Department or the Commission takes action affecting any development project subject to  
24 Section 411.1 et seq. and such action is subsequently modified, superseded, vacated, or  
25

1 reversed by the Board of Appeals, the Board of Supervisors, or by court action, the  
2 procedures of Section 402(c) of this Article shall be followed.

3 **SEC. 412.4. IMPOSITION OF DOWNTOWN PARK FEE REQUIREMENT.**

4 (a) **Determination of Requirements.** The Department shall determine the  
5 applicability of Section 412.1 et seq. to any development project requiring a *first construction*  
6 *document building or site permit* and, if Section 412.1 et seq. is applicable, the number of gross  
7 square feet of office use subject to its requirements, and shall impose this requirement as a  
8 condition of approval for issuance of the *first construction document building or site permit* for the  
9 *development* project to address the need for additional public park and recreation facilities in  
10 the downtown districts. The project sponsor shall supply any information necessary to assist  
11 the Department in this determination.

12 (b) **Amount of Fee.** The amount of the fee shall be \$2 per square foot of the net  
13 addition of gross floor area of office use to be constructed as set forth in the final approved  
14 building or site permit.

15 (c) **Department Notice to Development Fee Collection Unit at DBI.** After the  
16 Department has made its final determination of the net addition of gross floor area of office  
17 use subject to Section 412.1 et seq. and the dollar amount of the Downtown Park Fee  
18 required, the Department shall immediately notify the Development Fee Collection Unit at DBI  
19 of its determination, in addition to the other information required by Section 402(b) of this  
20 Article.

21 (d) **Process for Revisions of Determination of Requirement.** In the event that  
22 the Department or the Commission takes action affecting any development project subject to  
23 Section 412.1 et seq. and such action is subsequently modified, superseded, vacated, or  
24 reversed by the Board of Appeals, the Board of Supervisors, or by court action, the  
25 procedures of Section 402(c) of this Article shall be followed.

1           **SEC. 413.4. IMPOSITION OF HOUSING REQUIREMENT.**

2           (a)     **Determination of Requirements.** The Department shall determine the  
3 applicability of Section 413.1 et seq. to any development project requiring a *first construction*  
4 *document ~~building or site permit~~*, and if Section 413.1 et seq. is applicable, the number of gross  
5 square feet of each type of space subject to its requirements, and shall impose these  
6 requirements as a condition of approval for issuance of the *first construction document ~~building~~*  
7 for the development project to mitigate the impact on the availability of housing which will be  
8 caused by the employment facilitated by the development project. The project sponsor shall  
9 supply any information necessary to assist the Department in this determination.

10          (b)     **Department Notice to Development Fee Collection Unit at DBI of**  
11 ***Requirements.*** After the Department has made its final determination of the net addition of  
12 gross square feet of each type of space subject to Section 413.1 et seq., it shall immediately  
13 notify the Development Fee Collection Unit at DBI of its determination in addition to the other  
14 information required by Section 402(b) of this Article.

15          (c)     **Sponsor's Choice to Fulfill Requirements.** Prior to issuance of a building or  
16 site permit for a development project subject to the requirements of Section 413.1 et seq., the  
17 sponsor shall elect one of the three options listed below to fulfill any requirements imposed as  
18 a condition of approval and notify the Department of their choice of the following:

19               (1)     Contribute of a sum or land of value at least equivalent to the in-lieu fee,  
20 according to the formulas set forth in Section 413.6, to one or more housing developers who  
21 will use the funds or land to construct housing units pursuant to Section 413.5; or

22               (2)     Pay an in-lieu fee to the Development Fee Collection Unit at DBI according to  
23 the formula set forth in Section 413.6; or

24               (3)     Combine the above options pursuant to Section 413.8.  
25

1 (d) **Department's Notice to Development Fee Collection Unit of Sponsor's**  
2 **Choice.** After the project sponsor has notified the Department of the choice to fulfill the  
3 requirements of Section 413.1 et seq., the Department shall immediately notify the  
4 Development Fee Collection Unit at DBI of the project sponsor's choice.

5 (e) **Development Fee Collection Unit Notice to Department Prior to Issuance of**  
6 **the First Certificate of Occupancy.** The Development Fee Collection Unit at DBI shall  
7 provide notice in writing or electronically to the Department prior to issuing the first certificate  
8 of occupancy for any development project subject to Section 413.1 et seq. that has elected to  
9 fulfill all or part of the requirements with an option other than payment of an in-lieu fee. If the  
10 Department notifies the Unit at such time that the sponsor has not satisfied the requirements,  
11 the Director of DBI shall deny any and all certificates of occupancy until the subject project is  
12 brought into compliance with the requirements of Section 413.1 et seq.

13 ~~(e)~~ (f) **Process for Revisions of Determination of Requirements.** In the event that  
14 the Department or the Commission takes action affecting any development project subject to  
15 Section 413.1 et seq. and such action is subsequently modified, superseded, vacated, or  
16 reversed by the Board of Appeals, the Board of Supervisors, or by court action, the  
17 procedures of Section 402(c) shall be followed.

18 **SEC. 413.8. COMPLIANCE BY COMBINATION OF PAYMENT TO HOUSING**  
19 **DEVELOPER AND PAYMENT OF IN-LIEU FEE.**

20 With the written approval of the Director of MOH, the sponsor of a development project  
21 subject to Section 413.1 et seq. may elect to satisfy its housing requirement by a combination  
22 of paying money or contributing land to one or more housing developers under Section 413.5  
23 and paying a partial amount of the in-lieu fee to the Development Fee Collection Unit at DBI  
24 under Section 413.6. In the case of such election, the sponsor must pay a sum such that each  
25 gross square foot of net addition of each type of space subject to Section 413.1 et seq. is

1 accounted for in either the payment of a sum or contribution of land to one or more housing  
2 developers or the payment of a fee to the Development Fee Collection Unit. The housing units  
3 constructed by a housing developer must conform to all requirements of Section 413.1 et  
4 seq., including, but not limited to, the proportion that must be affordable to qualifying  
5 households as set forth in Section 413.5. All of the requirements of Sections 413.5 and 413.6  
6 shall apply, including the requirements with respect to the timing of issuance of site and  
7 building permits, first construction documents, and certificates of occupancy for the development  
8 project and payment of the in-lieu fee.

9 **SEC. 414.4. IMPOSITION OF CHILD CARE REQUIREMENT.**

10 (a) **Determination of Requirements.** The Department shall determine the  
11 applicability of Section 414.1 et seq. to any development project requiring a first construction  
12 document ~~building or site permit~~ and, if Section 414.1 is applicable, the number of gross square  
13 feet of each type of space subject to its requirements, and shall impose these requirements as  
14 a condition of approval for issuance of the first construction document ~~building or site permit~~ for  
15 the development project to mitigate the impact on the availability of child-care facilities which  
16 will be caused by the employees attracted to the proposed development project. The project  
17 sponsor shall supply any information necessary to assist the Department in this determination.

18 (b) **Department Notice to Development Fee Collection Unit at DBI of**  
19 **Requirements.** After the Department has made its final determination of the net addition of  
20 gross square feet of each type of space subject to Section 414.1 et seq., it shall immediately  
21 notify the Development Fee Collection Unit at DBI of its determination in addition to the other  
22 information required by Section 402(b) of this Article.

23 (c) **Sponsor's Choice to Fulfill Requirements.** Prior to issuance of a building or  
24 site permit for a development project subject to the requirements of Section 414.1 et seq., the  
25

1 sponsor shall elect one of the six options listed below to fulfill any requirements imposed as a  
2 condition of approval and notify the Department of their choice of the following:

3 (1) Provide a child-care facility on the premises of the development project for the  
4 life of the project pursuant to Section 414.5; or

5 (2) In conjunction with the sponsors or one or more other development projects  
6 subject to Section 414.1 et seq. located within 1/2 mile of one another, provide a single child-  
7 care facility on the premises of one of their development projects for the life of the project as  
8 set forth in Section 414.6; or

9 (3) Either singly or in conjunction with the sponsors or one or more other  
10 development projects subject to Section 414.1 et seq. located within 1/2 mile of one another,  
11 provide a single child-care facility to be located within one mile of the development project(s)  
12 pursuant to Section 414.7; or

13 (4) Pay an in-lieu fee to the Development Fee Collection Unit at DBI pursuant to  
14 Section 414.8; or

15 (5) Combine payment of an in-lieu fee to the Child Care Capital Fund with  
16 construction of a child-care facility on the premises or providing child-care facilities near the  
17 premises, either singly or in conjunction with other sponsors pursuant to Section 414.9; or

18 (6) Enter into an arrangement pursuant to which a nonprofit organization shall  
19 provide a child-care facility at a site within the City pursuant to Section 414.10.

20 (d) **Department Notice to Development Fee Collection Unit of Sponsor's**  
21 **Choice.** After the project sponsor has notified the Department of their choice to fulfill the  
22 requirements of Section 414.1 et seq., the Department shall immediately notify the  
23 Development Fee Collection Unit at DBI of the sponsor's choice.

24 (e) **Development Fee Collection Unit Notice to Department Prior to Issuance of**  
25 **the First Certificate of Occupancy.** The Development Fee Collection Unit at DBI shall



1 provide notice in writing or electronically to the Department prior to issuing the first certificate  
2 of occupancy for any development project subject to Section 414.1 et seq. that has elected to  
3 fulfill all or part of its requirement with an option other than payment of an in-lieu fee. If the  
4 Department notifies the Unit at such time that the sponsor has not satisfied the requirements,  
5 the Director of DBI shall deny any and all certificates of occupancy until the subject project is  
6 brought into compliance with the requirements of Section 414.1 et seq.

7 (f) **Process for Revisions of Determination of Requirements.** In the event that  
8 the Department or Commission takes action affecting any development project subject to  
9 Section 414.1 et seq. and such action is subsequently modified, superseded, vacated, or  
10 reversed by the Board of Appeals, the Board of Supervisors, or by court action, the  
11 procedures of Section 402(c) of this Article shall be followed.

12 **SEC. 414.10. COMPLIANCE BY ENTERING INTO AN ARRANGEMENT WITH A**  
13 **NON-PROFIT ORGANIZATION.**

14 The sponsor of a development project subject to this Section may elect to satisfy its  
15 child-care requirement by entering into an arrangement pursuant to which a nonprofit  
16 organization will provide a child-care facility at a site within the City. The sponsor shall, prior to  
17 the issuance of the first certificate of occupancy by the Director of DBI for the development  
18 project, provide proof to the Director of Planning that:

19 (a) A space for a child-care facility has been provided by the nonprofit organization,  
20 either for its own use if the organization will provide child-care services, or to a nonprofit child-  
21 care provider without charge for rent, utilities, property taxes, building services, repairs, or any  
22 other charges of any nature, as evidenced by a lease or sublease and an operating  
23 agreement between the nonprofit organization and the provider with minimum terms of three  
24 years;

25 (b) The child-care facility is a licensed child-care facility;

1 (c) The child-care facility has a minimum gross floor area of 3,000 square feet or an  
2 area determined according to the following formula, whichever is greater:

3 Net add. gross sq. ft. office or hotel space  $\times$  .01 = sq. ft. of child-care facility

4 In the event that the net addition of gross square feet of office or hotel space is less  
5 than 300,000 square feet, the child-care facility may have a minimum gross floor of 2,000  
6 square feet or the area determined according to the above formula, whichever is greater;

7 (d) The nonprofit organization has executed and recorded a binding written  
8 agreement, with a term of 20 years from the date of issuance of the first certificate of  
9 occupancy for the development project, pursuant to which the nonprofit organization  
10 guarantees that it will operate a child-care facility or it will lease or sublease a child-care  
11 facility to one or more nonprofit child-care providers for as long as there is a demonstrated  
12 need under Section 414.12, and that it will comply with all of the requirements imposed on the  
13 nonprofit organization under Section 414.10 and imposed on a sponsor under Sections 414.4.

14 (e) To support the provision of a child-care facility in accordance with the foregoing  
15 requirements, the sponsor has paid to the nonprofit organization a sum which equals or  
16 exceeds the amount of the in-lieu fee which would have been applicable to the project under  
17 Section 414.8 ~~414.4(b)(4)~~.

18 (f) The Department of Children, Youth and Their Families has determined that the  
19 proposed child-care facility will help meet the needs identified in the San Francisco Child Care  
20 Needs Assessment and will be consistent with the City Wide Child Care Plan; provided,  
21 however, that this Paragraph (f) ~~(F)~~ shall not apply to any office or hotel development project  
22 approved by the Planning Commission prior to December 31, 1999.

23 Upon compliance with the requirements of this Section, the nonprofit organization shall  
24 enjoy all of the rights and be subject to all of the obligations of the sponsor, and the sponsor  
25 shall have no further rights or obligations under Section 414.1 et seq.

1           **SEC. 414.14. CHILD CARE CAPITAL FUND.**

2           There is hereby established a separate fund set aside for a special purpose called the  
3 Child Care Capital Fund ("Fund"). All monies contributed pursuant to the provisions of Section  
4 414.1 et seq., and all other monies from the City's General Fund or from contributions from  
5 third parties designated for the fund shall be deposited in the Fund. All monies in the fund  
6 shall be used solely to increase and/or improve the supply of child care facilities affordable to  
7 households of low and moderate income; except that monies from the fund shall be used by  
8 the Director to fund in a timely manner any nexus study required to demonstrate the  
9 relationship between commercial development projects and child care demand as described  
10 in Section 414.1 414.4. The Fund shall be administered by the Director, who shall adopt rules  
11 and regulations governing the disposition of the Fund which are consistent with Section 414.1  
12 et seq. Such rules and regulations shall be subject to approval by resolution of the Board of  
13 Supervisors.

14           **SEC. 414.15. DECREASE IN CHILD CARE FORMULAE AFTER STUDY.**

15           If the Commission determines after review of an empirical study that the formulae set  
16 forth in Sections 414.4 414.5 through 414.9 impose a greater requirement for child care facilities  
17 than is necessary to provide child care for the number of employees attracted to office and  
18 hotel development projects subject to Section 414.1 et seq., the Commission shall, within  
19 three years of making such determination, refund that portion of any fee paid or permit a  
20 reduction of the space dedicated for child care by a sponsor consistent with the conclusions of  
21 such study. The Commission shall adjust any sponsor's requirement and the formulae set  
22 forth in Sections 414.4 414.5 through 414.9 so that the amount of the exaction is set at the level  
23 necessary to provide child care for the employees attracted to office and hotel development  
24 projects subject to Section 414.1 et seq.

25           **SEC. 416.3. APPLICATION OF AFFORDABLE HOUSING REQUIREMENT.**

1 The requirements of Sections 415.1 through 415.9 shall apply in the Market and  
 2 Octavia Plan Area in addition to the following additional affordable housing requirement:

3 (a) **Amount of Fee.** All development projects that have not received Department or  
 4 Commission approval as of the effective date of May 30, 2008 and that are subject to the  
 5 Residential Inclusionary Affordable Housing Program shall pay an additional affordable  
 6 housing fee per the fee schedule in Table 416.3A.

23 (b) **Other Fee Provisions.** This additional affordable housing fee shall be subject to  
 24 the inflation adjustment provisions of Section 409 and the waiver and reduction provisions of  
 25 Section 406 ~~421.4~~. This additional affordable housing fee may not be met through the in-kind

1 provision of community improvements or Community Facilities (Mello Roos) financing options  
2 of Sections ~~426.3~~ 421.3(d) and (e) and (f).

3 (c) **Exemption for Affordable Housing.** A project applicant shall not pay a  
4 supplemental affordable housing fee for any square foot of space designated as a below  
5 market rate unit under Section 415.1 et seq., the Citywide Inclusionary Affordable Housing  
6 Program, or any other residential unit that is designated as an affordable housing unit under a  
7 Federal, State, or local restriction in a manner that maintains affordability for a term no less  
8 than 50 years.

9 (d) **Timing of Payment.** The Market and Octavia Plan Area Affordable Housing Fee  
10 shall be paid before the City issues a first construction document, with an option for the  
11 project sponsor to defer payment to prior to issuance of the first certificate of occupancy upon  
12 agreeing to pay a deferral surcharge in accordance with Section 107A.13.3 of the San  
13 Francisco Building Code.

#### 14 **SEC. 417.4. IMPOSITION OF AFFORDABLE HOUSING REQUIREMENT.**

15 **Determination of Requirements.** The Department shall determine the applicability of  
16 Section 417.1 et seq. to any development project requiring a first construction document ~~building~~  
17 ~~or site permit~~ and, if Section 417.1 et seq. is applicable, shall impose any such requirements  
18 as a condition of approval for issuance of the first construction document for ~~building or site~~  
19 ~~permit~~ the development project. The project sponsor shall supply any information necessary to  
20 assist the Department in this determination.

21 (b) **Department Notice to Development Fee Collection Unit at DBI of Fee**  
22 **Requirements.** After the Department has made its final determination regarding the application  
23 of the affordable housing requirements to a development project pursuant to Section 417.1 et  
24 seq., it shall immediately notify the Development Fee Collection Unit at DBI of the applicable  
25

1 affordable housing fee amount in addition to the other information required by Section 402(b)  
2 of this Article.

3 **(c) Process for Revisions of Determination of Requirements.** In the event that  
4 the Department or the Commission takes action affecting any development project subject to  
5 Section 417.1 et seq. and such action is subsequently modified, superseded, vacated, or  
6 reversed by the Board of Appeals, the Board of Supervisors, or by court action, the  
7 procedures of Section 402(c) shall be followed.

8 **SEC. 418.4. IMPOSITION OF COMMUNITY INFRASTRUCTURE IMPACT FEE AND**  
9 **SOMA STABILIZATION FEE.**

10 **(a) Determination of Requirements.** The Department or Commission shall  
11 determine the applicability of Section 418.1 et seq. to any development project requiring a *first*  
12 *construction document* ~~building or site permit~~ and, if Section 418.1 et seq. is applicable, the  
13 amount of Community Infrastructure Impact and SOMA Stabilization Fees required and shall  
14 impose these requirements as a condition of approval for issuance of the *first construction*  
15 *document* ~~building or site permit~~ for the development project. The project sponsor shall supply  
16 any information necessary to assist the Department in this determination.

17 **(b) Department's Notice to Development Fee Collection Unit at DBI of**  
18 **Requirements.** Prior to issuance of a building or site permit for a development project subject to  
19 the requirements of Section 418.1 et seq., the Department shall notify the Development Fee  
20 Collection Unit at DBI of its final determination of the amount of Community Infrastructure and  
21 SOMA Stabilization Fees required, including any fee credits for in-kind improvements, in  
22 addition to the other information required by Section 402(b) of this Article.

23 **(c) Development Fee Collection Unit's Notice to Department Prior to Issuance**  
24 **of the First Certificate of Occupancy.** The Development Fee Collection Unit at DBI shall  
25 provide notice in writing and electronically to the Department prior to issuing the first certificate

1 of occupancy for any development project subject to Section 418.1 et seq. that has elected to  
2 fulfill all or part of the requirement with an In-Kind Improvement Agreement. If the Department  
3 notifies the Unit at such time that the sponsor has not satisfied the requirements, the Director  
4 of DBI shall deny any and all certificates of occupancy until the subject project is brought into  
5 compliance with the requirements of Section 418.1 et seq.

6 (d) *Process for Revisions of Determination of Requirements.* In the event that the  
7 Department or the Commission takes action affecting any development project subject to  
8 Section 418.1 et seq. and such action is subsequently modified, superseded, vacated, or  
9 reversed by the Department or the Commission, Board of Appeals, the Board of Supervisors,  
10 or by court action, the procedures of Section 402(c) shall be followed.

11 **SEC. 419.2. DEFINITIONS.** (a) In addition to the definitions set forth in Section 401  
12 of this Article:

13 (1) "Rental Housing Project" shall mean a project consisting solely of rental housing  
14 units, as defined in Section ~~401 415.1(37)~~ that meets the following requirements:

15 (A) The units shall be rental housing for not less than 30 years from the issuance of  
16 the certificate of occupancy pursuant to an agreement between the developer and the City.  
17 This agreement shall be in accordance with applicable State law governing rental housing;

18 (B) A Notice of Special Restrictions (NSR), with the City as a third party beneficiary  
19 and subject to written approval of the Director, shall be recorded on the title of the property  
20 prior to final map approval containing the terms of the agreement described above in  
21 subsection (1). Once the agreement is recorded against the property, the NSR shall  
22 terminate.

23 (2) "Tier A." Sites within the UMU which do not receive zoning changes that  
24 increase heights, as compared to allowable height prior to the rezoning (May 2008).

1 (3) "Tier B." Sites within the UMU which receive zoning changes that increase  
2 heights by one to two stories.

3 (4) "Tier C." Sites within the UMU which receive zoning changes that increase  
4 heights by three or more stories.

5 **SEC. 419.3. APPLICATION OF UMU AFFORDABLE HOUSING REQUIREMENTS.**

6 Section 419.1 et seq. shall apply to any housing project located in the UMU Zoning  
7 District of the Eastern Neighborhoods, that is subject to the requirements of Section 415 et  
8 seq.

9 (b) Additional UMU Affordable Housing Requirements to the Section 415  
10 Inclusionary Affordable Housing Program Requirements. The requirements of Section 415  
11 through 415.9 shall apply subject to the following exceptions:

12 (1) For all projects sites designated as Tier A, a minimum of 18 percent of the total  
13 units constructed shall be affordable to and occupied by qualifying persons and families as  
14 defined elsewhere in this Code, so that a project sponsor must construct .18 times the total  
15 number of units produced in the principal project beginning with the construction of the fifth  
16 unit. If the total number of units is not a whole number, the sponsor shall round up to the  
17 nearest whole number for any portion of .5 or above.

18 (A) If the project sponsor *is eligible for and* elects pursuant to Section 415.5(g)  
19 ~~415.4(e)(2)~~, to build off-site units to satisfy the requirements of this program, the sponsor shall  
20 construct 23 percent so that a sponsor must construct .23 times the total number of units  
21 produced in the principal project beginning with the construction of the fifth unit. If the total  
22 number of units is not a whole number, the sponsor shall round up to the nearest whole  
23 number for any portion of .5 or above.

24 (B) If the project sponsor elects pursuant to Section 415.5 ~~415.4(e)(3)~~ to pay *an-in-lieu*  
25 the fee to satisfy the requirements of this program, the sponsor shall meet the requirements of



1 Section 415 according to the number of units required above if the project applicant were to  
2 elect to meet the requirements of this Section by off-site housing development. For the  
3 purposes of this Section, the City shall calculate the fee using the direct fractional result of the  
4 total number of units multiplied by the percentage of off-site housing required, rather than  
5 rounding up the resulting figure *as required by Section 415.6(a)*.

6 (2) For all project sites designated Tier B, a minimum of 20 percent of the total units  
7 constructed shall be affordable to and occupied by qualifying persons and families as defined  
8 elsewhere in this Code, so that a project sponsor must construct .20 times the total number of  
9 units produced in the principal project beginning with the construction of the fifth unit. If the  
10 total number of units is not a whole number, the sponsor shall round up to the nearest whole  
11 number for any portion of .5 or above.

12 (A) If the project sponsor *is eligible for and* elects pursuant to Section *415.5(g)*  
13 *415.4(e)(2)*, to build off-site units to satisfy the requirements of this program, the sponsor shall  
14 construct 25 percent so that a sponsor must construct .25 times the total number of units  
15 produced in the principal project beginning with the construction of the fifth unit. If the total  
16 number of units is not a whole number, the sponsor shall round up to the nearest whole  
17 number for any portion of .5 or above.

18 (B) If the project sponsor elects pursuant to Section *415.5(g) 415.4(e)(3)* to pay *an in-*  
19 *lieu the* fee to satisfy the requirements of this program, the sponsor shall meet the  
20 requirements of Section 415 according to the number of units required above if the sponsor  
21 were to elect to meet the requirements of this Section by off-site housing development. For  
22 the purposes of this Section, the City shall calculate the fee using the direct fractional result of  
23 the total number of units multiplied by the percentage of off-site housing required, rather than  
24 rounding up the resulting figure *as required by Section 415.6(a)*.

1 (3) For all project sites designated Tier C, a minimum of 22 percent of the total units  
2 constructed shall be affordable to and occupied by qualifying persons and families as defined  
3 elsewhere in this Code, so that a project sponsor must construct .22 times the total number of  
4 units produced in the principal project beginning with the construction of the fifth unit. If the  
5 total number of units is not a whole number, the sponsor shall round up to the nearest whole  
6 number for any portion of .5 or above.

7 (A) If the project sponsor *is eligible for and* elects pursuant to Section 415.5(g)  
8 ~~415.4(e)(2)~~, to build off-site units to satisfy the requirements of this program, the sponsor shall  
9 construct 27 percent so that a sponsor must construct .27 times the total number of units  
10 produced in the principal project beginning with the construction of the fifth unit. If the total  
11 number of units is not a whole number, the sponsor shall round up to the nearest whole  
12 number for any portion of .5 or above.

13 (B) If the project sponsor elects pursuant to Section 415.5 ~~415.4(e)(3)~~ to pay *an in-lieu*  
14 *the* fee to satisfy the requirements of this program, the sponsor shall meet the requirements of  
15 Section 415 according to the number of units required above if the sponsor were to elect to  
16 meet the requirements of this Section by off-site housing development. For the purposes of  
17 this Section, the City shall calculate the fee using the direct fractional result of the total  
18 number of units multiplied by the percentage of off-site housing required, rather than rounding  
19 up the resulting figure *as required by Section 415.6(a)*.

20 (c) Timing and Payment of Fee. Any fee required by Section 419.1 et seq. shall be  
21 paid to the Development Fee Collection Unit at DBI prior to issuance of the first construction  
22 document, with an option for the project sponsor to defer payment to prior to issuance of the  
23 first certificate of occupancy upon agreeing to pay a deferral surcharge in accordance with  
24 Section 107A.13.3 of the San Francisco Building Code.

25 **SEC. 419.4. IMPOSITION OF UMU AFFORDABLE HOUSING REQUIREMENTS.**

1 The Department shall determine the applicability of Section 419.1 et seq. to any  
2 development project requiring a first construction document ~~building or site permit~~ and, if Section  
3 419.1 et seq. is applicable, the additional affordable housing required pursuant to Section  
4 419.1 et seq. and shall impose these requirements as condition on the approval for issuance  
5 of the first construction document ~~building or site permit~~ for the development project. The project  
6 sponsor shall supply any information necessary to assist the Department in this determination.

7 (b) **Notice to Development Fee Collection Unit at DBI of Requirements.** After the  
8 Department has made its final determination of the additional affordable housing required  
9 pursuant to Section 419.1 et seq., it shall immediately notify the Development Fee Collection  
10 Unit at DBI of its determination in addition to the other information required by Section 402(b)  
11 of this Article.

12 (c) **Sponsor's Choice to Fulfill Requirements.** Prior to issuance of a building or  
13 site permit for a development project subject to the requirements of Section 419.1 et seq., the  
14 sponsor of the development project shall select one of the options described in Section 419.3  
15 above or the alternatives described in Section 419.5 below to fulfill the affordable housing  
16 requirements and notify the Department of their choice.

17 (d) **Department Notice to Development Fee Collection Unit of Sponsor Choice.**  
18 After the sponsor has notified the Department of their choice to fulfill the additional affordable  
19 housing requirements of Section 419.1 et seq., the Department shall immediately notify the  
20 Development Fee Collection Unit at DBI of the sponsor's choice.

21 (e) **The Development Fee Collection Unit Notice to Department Prior to**  
22 **Issuance of the First Certificate of Occupancy.** The Development Fee Collection Unit at  
23 DBI shall provide notice in writing or electronically to the Department prior to issuing the first  
24 certificate of occupancy for any development project subject to Section 419.1 et seq. that has  
25 elected to fulfill its requirement with an option other than payment of an in-lieu fee. If the

1 Department notifies the Unit at such time that the sponsor has not satisfied the requirements,  
2 the Director of DBI shall deny any and all certificates of occupancy until the subject project is  
3 brought into compliance with the requirements of Section 419.1 et seq.

4 (f) **Process for Revisions of Determination of Requirements.** In the event that  
5 the Department or the Commission takes action affecting any development project subject to  
6 Section 419.1 et seq. and such action is subsequently modified, superseded, vacated, or  
7 reversed by the Department or the Commission, Board of Appeals, the Board of Supervisors,  
8 or by court action, the procedures of Section 402(c) of this Article shall be followed.

9 **SEC. 419.5. ALTERNATIVES TO THE INCLUSIONARY HOUSING COMPONENT.**

10 (a) **Alternatives to the Inclusionary Housing Component.** In addition to the  
11 alternatives specified in Section ~~415.5(9) 415.4(e), (and further described above and in Section~~  
12 ~~415.6, Compliance Through Off-Site Housing Development, and Section 415.7. Compliance Through~~  
13 ~~In-Lieu Fee, and described further above,~~ the project sponsor may elect to satisfy the  
14 requirements of Section 415.5 by one of the alternatives specified in this Section. The project  
15 sponsor has the choice between the alternatives and the Planning Commission may not  
16 require a specific alternative. The project sponsor must elect an alternative before it receives  
17 project approvals from the Planning Commission or Planning Department and that alternative  
18 will be a condition of project approval. The alternatives are as follows:

19 (1) **Middle Income Alternative.** On sites with less than 50,000 square feet of total  
20 developable area, applicants may provide units as affordable to qualifying "middle income"  
21 households as follows:

22 (A) A minimum percent of the total units constructed shall be affordable to and  
23 occupied affordable to qualifying "middle income" households upon initial sale, according the  
24 schedule in Table 419A.4. If the total number of units is not a whole number, the project  
25 applicant shall round up to the nearest whole number for any portion of .5 or above. Units

1 shall be affordable to households between 120 percent and 150 percent of the San Francisco  
2 Area Median Income, with an average affordability level of 135 percent for all units provided  
3 through this alternative.

4 (B) Where market rate sales prices exceed restricted sales prices, the difference  
5 between the market rate sales prices and the restricted sales prices shall be held by the  
6 Mayor's Office of Housing as a silent second mortgage according to the Procedures Manual.  
7 The City shall hold a deed of trust and promissory note for the second mortgage. MOH shall  
8 hold this mortgage shall release it when the original note and proportional share of the  
9 appreciation are paid in full to the City.

10 (C) Units shall initially be sold at or below prices to be determined by MOH in the  
11 Conditions of Approval or Notice of Special Restrictions according to the formula specified in  
12 the Procedures Manual to make them affordable to middle income households. Upon resale,  
13 the seller shall be permitted to sell the units at their market price. The City will waive its right  
14 of first refusal to the seller when the promissory note and deed of trust are paid, along with the  
15 City's share of the appreciation of the unit. The promissory note shall accrue no interest and  
16 shall require no monthly payments.

17 (D) Upon first resale, the seller shall have a right to keep a percentage of the total  
18 appreciation of the unit proportional to every year the original seller owns the unit as an owner  
19 occupant. The remainder of the proceeds of the sale, after the first mortgage, the second  
20 mortgage, and any other subordinate financing is paid off, shall be repaid to MOH. Detailed  
21 resale procedures shall be specified in the Middle Income Housing Procedures Manual  
22 published by MOH and approved by the Planning Commission. The Director of MOH shall  
23 amend the Procedures Manual as needed with the Commission's approval.

24 (E) The City shall monitor units provided under this option during the 2- and 5-year  
25 Monitoring Report specified in Section 342 of this Code and in separate resolution. Should

1 this monitoring report indicate that units constructed under this program do not meet the  
2 programs stated goals of providing affordable housing to Middle Income Households, the  
3 Planning Department and MOH shall consider changes to this program, including, but not  
4 limited to, legislative changes.

5 (F) If the project sponsor elects to satisfy the requirements of Section 415.5 and of  
6 this Section by the alternative specified above, the requirement that 40 percent of the total  
7 number of proposed dwelling units shall contain at least two bedrooms may be waived  
8 provided the minimum percent of total units affordable to qualifying "middle income" as  
9 required by Table 419A.4 is increased by 10%.

10 (2) **Land Dedication Alternative.** Applicants may dedicate a portion of the total  
11 developable area of the principal site to the City and County of San Francisco for the purpose  
12 of constructing units affordable to qualifying households. A minimum percentage of  
13 developable area, representing an equivalent percent of total potential units to be constructed,  
14 shall be dedicated to the City according the schedule in Table 419A.4. To meet the  
15 requirements of this alternative, the developer must convey title to land in fee simple absolute  
16 to MOH according to the Procedures Manual, provided the dedicated site is deemed of  
17 equivalent or greater value to the principal site per those procedures and is in line with the  
18 following requirements:

19 (A) The dedicated site will result in a total amount of inclusionary units not less than  
20 forty (40) units. MOH may conditionally approve and accept dedicated sites which result in no  
21 less than twenty-five (25) units at its discretion.

22 (B) The dedicated site will result in a total amount of inclusionary units that is  
23 equivalent or greater than the minimum percentage of the units that will be provided on the  
24 principal site, as required by Table 419A.4. MOH may also accept dedicated sites that  
25 represent the equivalent of or greater than the required percentage of units for all units be

1 provided on a collective of sites within a one-mile radius, provided the total amount of  
2 inclusionary units provided on the dedicated site is equivalent to or greater than the total  
3 requirements for all principal sites participating in the collective, according to the requirements  
4 of Table 419A.4.

5 (C) The dedicated site is suitable from the perspective of size, configuration,  
6 physical characteristics, physical and environmental constraints, access, location, adjacent  
7 use, and other relevant planning criteria. The site must allow development of affordable  
8 housing that is sound, safe and acceptable.

9 (D) The dedicated site includes infrastructure necessary to serve the inclusionary  
10 units, including sewer, utilities, water, light, street access and sidewalks.

11 (E) The developer must submit full environmental clearance for the dedicated site  
12 before the land can be considered for conveyance, and before a first site or building permit  
13 may be conferred upon the principal project.

14 (F) The City may accept dedicated sites that vary from the minimum threshold  
15 provided such a dedication is deemed generally equivalent to the original requirement by the  
16 Mayor's Office of Housing.

17 (G) The City may accept dedicated sites that meet the above requirements in  
18 accordance with the Procedures Manual, in combination with ~~in-lieu~~ fees or on-site units,  
19 provided such a combination is deemed generally equivalent by MOH to the original  
20 requirement.

21 (H) The project applicant has a letter from MOH verifying acceptance of site before it  
22 receives project approvals from the Planning Commission or Planning Department, which  
23 shall be used to verify dedication as a condition of approval.

(I) If the project sponsor elects to satisfy the requirements of Section 415.5 and of this Section by the alternative specified above, the requirement that 40 percent of the total number of proposed dwelling units shall contain at least two bedrooms may be waived.

(J) The Land Dedication Alternative may be satisfied through the dedication to the City of air space above or adjacent to the project, upon the approval of MOH, or a successor entity, and provided the other requirements of subsection (a)(2)(A)—(I) are otherwise satisfied.

(b) Rental Incentive. Qualified rental housing projects, as defined in Section 419A.2(g), are allowed a reduction in their inclusionary housing requirements as follows:

(1) If the rental housing project chooses to meet its inclusionary housing requirements through on-site construction, off-site construction, or an in-lieu fee, then the project is entitled to a 3% reduction in the requirements specified above in subsection (a).



1 (2) If the rental housing project chooses to meet its inclusionary housing  
2 requirements through the land dedication option for projects less than 30,000 square feet,  
3 then the project is entitled to a 5% reduction in the requirements specified above in the  
4 subsection (b)(2).

5 (3) In addition, a rental housing project shall receive a fee waiver from the Eastern

8 (4) No rental incentive shall be provided for project that chooses the land dedication  
9 alternative for projects over 30,000 square feet.

10 (c) **Adjustments to Requirements for the Inclusionary Housing Component.**

11 This Section is intended to incorporate, rather than supersede, any changes made to Planning  
12 Code Section 415. In the instance that the base requirements of Section 415 are amended,  
13 the above-noted requirements shall be reviewed, and if appropriate, amended and/or  
14 increased accordingly.

15 **SEC. 420. VISITACION VALLEY COMMUNITY FACILITIES AND**  
16 **INFRASTRUCTURE FEE AND FUND.**

17 Sections 420.1 through 420.6~~5~~, hereafter referred to as Section 420.1 et seq., set forth  
18 the requirements and procedures for the Visitacion Valley Community Facilities and  
19 Infrastructure Fee and Fund. The effective date of these requirements shall be either  
20 November 18, 2005, which is the date that the requirements originally became effective, or

22 **SEC 420.4. IMPOSITION OF REQUIREMENTS.**

2 requirements as a condition of approval for issuance of the first construction document building  
3 or site permit for the development project. The project sponsor shall supply any information  
4 necessary to assist the Department in this determination.

5 (b) **Department Notice to Development Fee Collection Unit at DBI of**  
6 **Requirements.** Prior to issuance of the building or site permit for a development project subject  
7 to Section 420 et seq., the Department shall notify the Development Fee Collection Unit at  
8 DBI of its final determination of any fee requirements, including any fee credits for in-kind  
9 improvements, in addition to the other information required by Section 402(b) of this Article.

10 (c) **Development Fee Collection Unit Notice to Department.** The Development  
11 Fee Collection Unit at DBI shall provide notice in writing or electronically to the Department  
12 prior to issuing the first certificate of occupancy for any development project subject to Section  
13 420.1 et seq. that has elected to satisfy its fee requirement with credits-in-kind improvements.  
14 If the Department notifies the Unit at such time that the sponsor has not satisfied the in-kind  
15 improvements requirements of Section 420.3, the Director of DBI shall deny any and all  
16 certificates of occupancy until the subject project is brought into compliance.

17 (d) **Process for Revisions of Determination of Requirements.** In the event that  
18 the Department or the Commission takes action affecting any development project subject to  
19 Section 420.1 et seq. and such action is subsequently modified, superseded, vacated, or  
20 reversed by the Department or the Commission, Board of Appeals, the Board of Supervisors,  
21 or by court action, the procedures of Section 402(c) of this Article shall be followed.

#### 22 **SEC. 420.5 4. LIEN PROCEEDINGS.**

23 If, for any reason, the fee imposed under Section 420.3 remains unpaid following  
24 issuance of the certificate of occupancy, the Development Fee Collection Unit at DBI shall  
25 institute lien proceedings to make the entire unpaid balance of the fee, plus interest and any

1 deferral surcharge, a lien against all parcels used for the development project in accordance  
2 with Section 408 of this Article and Section 107A.13.215 of the San Francisco Building Code.

3 **SEC. 420.65. VISITACION VALLEY COMMUNITY FACILITIES AND**  
4 **INFRASTRUCTURE FUND.**

5 (a) There is hereby established a separate fund set aside for a special purpose  
6 entitled the Visitacion Valley Community Facilities and Infrastructure Fund ("Fund"). All  
7 monies collected by DBI pursuant to Section 420.3(b) shall be deposited in the Fund which  
8 shall be maintained by the Controller.

9 (b) The receipts in the Fund are, subject to the budgetary and fiscal provisions of  
10 the Charter, to be used solely to fund community facilities and infrastructure in Visitacion  
11 Valley, including but not limited to capital improvements to library facilities, playgrounds,

13 (c) No portion of the Fund may be used, by way of loan or otherwise, to pay any  
14 administrative, general overhead, or similar expense of any public entity.

15 (d) The Controller shall not release any monies from the Fund without prior approval  
16 of the Board of Supervisors for an expenditure. City Agencies responsible for the construction  
17 or improvement of public infrastructure subject to this ordinance, including but not limited to  
18 the San Francisco Public Library, DPW, and the Department of Recreation and Parks, shall  
19 request funds from the Board of Supervisors as necessary. Before approving any  
20 expenditures, the Board of Supervisors shall determine the relative impact from the residential  
21 development on public infrastructure in Visitacion Valley described in Section 420.56(b) and  
22 shall insure that the expenditures are consistent with mitigating the impacts from the  
23 development.

1 (e) The Controller's Office shall file an annual report with the Board of Supervisors  
2 beginning one year after the effective date of Section ~~420.1 418.1~~ et seq., which report shall  
3 set forth the amount of money collected in the Fund.

4 **SEC. 421.4. IMPOSITION OF COMMUNITY INFRASTRUCTURE IMPACT FEE.**

5 (a) **Determination of Requirements.** The Department shall determine the  
6 applicability of Section 421.1 et seq. to any development project requiring a *first construction*  
7 *document* ~~building or site permit~~ and, if Section 421.1 is applicable, the number of gross square  
8 feet of each type of space subject to its requirements, and shall impose these requirements as  
9 a condition of approval for issuance of the *first construction document* ~~building or site permit~~ for  
10 the *development* project to mitigate the development impacts. The project sponsor shall supply  
11 any information necessary to assist the Department in this determination.

12 (b) **Department Notice to Development Fee Collection Unit at DBI of**  
13 ***Requirements.*** After the Department has made its final determination of the net addition of  
14 gross square feet of each type of space subject to Section 421.1 et seq., it shall immediately  
15 notify the Development Fee Collection Unit at DBI of its determination in addition to the other  
16 information required by Section 402(b) of this Article.

17 (c) **Sponsor's Choice to Fulfill Requirements.** Prior to issuance of a building or  
18 site permit for a development project subject to the requirements of Section 421.1 et seq., the  
19 sponsor shall elect an option under Section 421.3 to fulfill the requirements of Section 421.1  
20 et seq. and notify the Department of their choice.

21 (d) **Department's Notice to Development Fee Collection Unit of Sponsor's**  
22 **Choice.** After the project sponsor has notified the Department of the choice to fulfill the  
23 requirements of Section 421.1 et seq., the Department shall immediately notify the  
24 Development Fee Collection Unit at DBI of the project sponsor's choice.

1 (e) **Development Fee Collection Unit Notice to Department Prior to Issuance of**  
2 **the First Certificate of Occupancy.** The Development Fee Collection Unit at DBI shall  
3 provide notice in writing or electronically to the Department prior to issuing the first certificate  
4 of occupancy for any development project subject to Section 421.1 et seq. that has elected to

6 Department notifies the Unit at such time that the sponsor has not satisfied the requirements,

24 Development Fee Collection Unit at DBI of its final determination of the amount of Community

16 Improvements Agreement. If the Department notifies the Unit at such time that the sponsor

19 compliance with the requirements of Section 422.1 et seq., either through conformance with

3 **SEC. 424.3. APPLICATION OF VAN NESS AND MARKET AFFORDABLE**

5 (a) Application. Section 424.1 et seq. shall apply to any development project located  
6 in the Van Ness and Market Downtown Residential Special Use District, as established in  
7 Section 249.33 of this Code.

8 (b) Amount of Fee.

9 (i) All uses in any development project within the Van Ness and Market Downtown  
10 Residential Special Use District shall pay \$30.00 per net additional gross square foot of floor  
11 area in any portion of building area exceeding the base development site FAR of 6:1 up to a  
12 base development site FAR of 9:1.

13 (ii) All uses in any development project within the Van Ness and Market Downtown  
14 Residential Special Use District shall pay \$15.00 per net additional gross square foot of floor  
15 area in any portion of building area exceeding the base development site FAR of 9:1.

16 (c) Option for In-Kind Provision of Infrastructure Improvements and Fee Credits.

17 Project sponsors may propose to directly provide community improvements to the City. In such a case,  
18 the City may enter into an In-Kind Improvements Agreement with the sponsor and issue a fee waiver  
19 from the neighborhood infrastructure portion (\$15.00 per net additional gross square foot of floor  
20 area) of the Van Ness and Market Downtown Residential Special Use District Affordable Housing and  
21 Neighborhood Infrastructure Fee from the Planning Commission, subject to the following rules and  
22 requirements:

23 (1) Approval criteria. The City shall not enter into an In-Kind Agreement unless the  
24 proposed in-kind improvements meet an identified community need as analyzed in the Van Ness and  
25 Market Affordable Housing and Neighborhood Infrastructure Program and where they substitute for



1 improvements that could be provided by the Van Ness and Market Downtown Residential Special Use  
2 District Infrastructure Fee Fund (as described in Section 424.5). The City may reject in-kind  
3 improvements if they are not consistent with the priorities identified in the Van Ness and Market  
4 Affordable Housing and Neighborhood Infrastructure Program. No physical improvement or provision  
5 of space otherwise required by the Planning Code or any other City Code shall be eligible for  
6 consideration as part of this In-Kind Improvements Agreement.

7 (2) Valuation. The Director of Planning shall determine the appropriate value of the  
8 proposed in-kind improvements. For the purposes of calculating the total value, the project sponsor  
9 shall provide the Planning Department with a cost estimate for the proposed in-kind improvement(s)  
10 from two independent sources or, if relevant, real estate appraisers. If the City has completed a  
11 detailed site-specific cost estimate for a planned improvement this may serve as one of the cost  
12 estimates provided it is indexed to current cost of construction.

13 (3) Content of the In-Kind Improvements Agreement. The In-Kind Improvements Agreement  
14 shall include at least the following items:

15 (i) A description of the type and timeline of the proposed in-kind improvements.

16 (ii) The appropriate value of the proposed in-kind improvement, as determined in subsection  
17 (2) above.

18 (iii) The legal remedies in the case of failure by the project sponsor to provide the in-kind  
19 improvements according to the specified timeline and terms in the agreement. Such remedies shall  
20 include the method by which the City will calculate accrued interest.

21 (4) Approval Process. The Planning Commission must approve the material terms of an In-  
22 Kind Agreement. Prior to the parties executing the Agreement, the City Attorney must approve the  
23 agreement as to form and to substance. The Director of Planning is authorized to execute the  
24 Agreement on behalf of the City. If the Planning Commission approves the In-Kind Agreement, it shall  
25 waive the amount of the neighborhood infrastructure portion of the Van Ness and Market Downtown

1 Residential Special Use District Affordable Housing and Neighborhood Infrastructure Fee by the value  
2 of the proposed In-Kind Improvements Agreement as determined by the Director of Planning. No credit  
3 shall be made for land value unless ownership of the land is transferred to the City or a permanent  
4 public easement is granted, the acceptance of which is at the sole discretion of the City. The maximum  
5 value of the In-Kind Improvements Agreement shall not exceed the required neighborhood  
6 infrastructure portion of the Van Ness and Market Affordable Housing and Neighborhood  
7 Infrastructure Fee.

8 (5) Administrative Costs. Project sponsors that pursue an In-Kind Improvements Agreement  
9 will be billed time and materials for any administrative costs that the Planning Department or any  
10 other City entity incurs in negotiating, drafting, and monitoring compliance with the In-Kind  
11 Improvements Agreement.

20 ~~to provide a letter of credit or other instrument, acceptable in form and substance to the Department~~

22 **SEC. 430. SEVERABILITY.**

23 In the event that a court or agency of competent jurisdiction holds that federal or state law, rule  
24 or regulation invalidates any clause, sentence, paragraph or section of this Article or the application  
25 thereof to any person or circumstances, it is the intent of the Board of Supervisors that the court or

1 agency sever such clause, sentence, paragraph or section so that the remainder of this Article shall  
2 remain in effect.

3 Section 3. If an evaluation comparable to that required by Section 410 of this Article  
4 was completed in 2010 or 2011 for a development fee imposed by this Article, that fee need  
5 not be included in the 2011 comprehensive five-year evaluation.

6 Section 4. The San Francisco Administrative Code is hereby amended by repealing  
7 Section 38.14, as follows:

8 **~~SEC. 38.14. SEVERABILITY.~~**

9 ~~The provisions of this ordinance shall not apply to any person, association, corporation or to~~  
10 ~~any property as to whom or which it is beyond the power of the City to impose the fee herein provided.~~  
11 ~~If any sentence, clause, section or part of this ordinance, or any fee imposed upon any person or entity~~
