1 (Settlement of Litigation)

2 AUTHORIZING SETTLEMENT OF LITIGATION BY THE CITY AND COUNTY OF SAN
3 FRANCISCO AGAINST EDWARD MIRON, EXECUTOR OF THE ESTATE OF LINDA
4 MIRON, DECEASED BY ACCEPTING THE TOTAL AMOUNT OF \$32,345.44 AND
5 DIRECTING ITS ATTORNEY TO SIGN THE MUTUAL SETTLEMENT AND RELEASE AND
6 DISMISSAL WITH PREJUDICE OF CCSF v. EDWARD MIRON, EXECUTOR.

9 Be it ordained by the People of the City and County of San Francisco.
10

11 Section 1. The Tax Collector Attorney in the Treasurer/Tax Collector Department is hereby
12 authorized and directed to settle the controversy in the action CCSF v. Edward Miron, Executor of
13 the Estate of Linda Miron, San Francisco Superior Court No. 303448 by signing the Mutual
14 Settlement Agreement and Release attached to this Ordinance as Appendix 1 and accepting the sum
15 of \$32,345.44 from Defendant Edward Miron on the date this ordinance is formally enacted and a
16 copy thereof is presented to Defendant through his attorney of record.

18 Section 2. After full payment of the amount specified in Section 1 and execution of the
19 Mutual Settlement and Release by Defendant Edward Miron, the Tax collector Attorney is directed
20 to prepare and file a dismissal with prejudice in the action CCSF v. Edward Miron, Executor of the
21 Estate of Linda Miron, San Francisco Superior Court No. 303448.

23 Section 3. In the event that there is any default in the Defendant's payment or other
24 obligations as provided in Section 1, the Mutual Settlement Agreement and Release shall become
25 null and void and the City may continue to litigate its Complaint in the subject action to trial.




