14 for the unexpired portion of a four-year term ending January 31, 2006;

15 Ralph Gibson, succeeding Vincent Rios, term expired, seat 7, must be a person who  
16 served in the Armed Forces of the United states of America and is suffering under a physical  
17 disability arising from that service, in accordance with the definitions applied in such cases by  
18 the Veterans' Administration, for a new four-year term ending January 31, 2007;

19 Bud Wilson, succeeding himself, term expired, seat 8, must be an at-large  
20 appointment, for a new four-year term ending January 31, 2007;

21 Aaron Zeff, succeeding himself, term expired, seat 11, must be an at-large  
22 appointment, for a new four-year term ending January 31, 2007.
