9 WHEREAS, Upon completion of a competitive selection process, the Airport  
10 Commission adopted Resolution No. 18-0205 on July 10, 2018, awarding the Terminal 1  
11 Retail Concession Lease 4 – Lease No. 18-0205 to L'Occitane Airport Venture, LLC; and

12 WHEREAS, The Terminal 1 Retail Concession Lease 4 - Lease No. 18-0205 has a  
13 term of seven years with two one-year options to extend, and an initial minimum annual  
14 guarantee of \$135,000; now, therefore, be it

15 RESOLVED, That this Board of Supervisors hereby approves the Terminal 1 Retail  
16 Concession Lease 4 - Lease No. 18-0205, a copy of which is on file with the Clerk of the  
17 Board of Supervisors in File No. 190019; and, be it

18 FURTHER RESOLVED, That within thirty (30) days of the lease being fully-executed by  
19 all parties, the Airport Commission shall provide the final lease to the Clerk of the Board for  
20 inclusion into the official file.


