3 Ordinance authorizing settlement of the portion of the lawsuit filed by Angela Sinicropi
4 and Martin Takigawa against the City and County of San Francisco for \$26,820; the
5 lawsuit was filed on January 31, 2005, in San Francisco Superior Court, Case No.
6 436930; entitled Jane Martin, et al. v. City and County of San Francisco, et al.

7 Be it ordained by the People of the City and County of San Francisco:

8 Section 1. The City Attorney is hereby authorized to settle the portion of the action
9 entitled "Jane Martin, et al. v. City and County of San Francisco, et al." San Francisco
10 Superior Court, Court No. 436930, as it relates only to co-plaintiffs Angela Sinicropi and
11 Martin Takigawa, by the payment of \$26,820, representing the claim for diminution of property
12 value, and excluding attorney's fees, costs and interest, which will be addressed in later
13 proceedings.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 January 31, 2005, and the following settling parties were named in the lawsuit: Plaintiffs
16 Angela Sinicropi and Martin Takigawa and Defendant City and County of San Francisco.
