I am a resident of the South of Market neighborhood writing to formally protest the issuance of a Type 21 Off-Sale General alcoholic beverage license to Royal Mart LLC at 1201 Howard Street.

First, I want to state my support for the new owners of this business. I appreciate their investment in our neighborhood and the significant improvements they have made to the store. A successful convenience store that provides groceries and other necessities is a vital asset to a dense, walkable community, and I support their continued success with their existing license to sell beer and wine.

My protest is not against the business itself, but is a targeted objection specifically to the addition of distilled spirits. My goal is to ensure that our neighborhood develops in a way that enhances public safety and livability for the thousands of residents who call SoMa home. The addition of hard liquor at this specific, troubled corner would directly undermine that goal.

Grounds for Protest:

- 1. Aggravation of a Law Enforcement Problem & Creation of a Public Nuisance: For a dense urban neighborhood to be successful, a baseline of public safety is essential. The issuance of this license would aggravate an existing police problem at a known hotspot for criminal activity. The sale of hard liquor would escalate the severity of incidents such as:
 - A physical assault that occurred at this corner on June 25, 2025.
 - A man menacing people with a weapon outside the premises on June 27, 2025.
 - Constant open-air drug use and public intoxication.
- 2. Interference with Quiet Enjoyment of a Dense Residential Area: My residence is in the immediate vicinity of the premises. The success of dense housing depends on residents' ability to have quiet enjoyment of their property. Patrons already create a nuisance by walking onto the residential 700 block of Tehama Street to urinate and defecate, a problem that increased access to hard liquor would worsen, degrading the livability of our community.
- 3. **Undue Concentration of Licenses:** A healthy neighborhood needs a balanced mix of commercial uses. This area is already saturated with alcohol outlets, which strains public

- safety resources. There is no public convenience or necessity for another license, especially one for distilled spirits, which would tip the balance from commercial vibrancy to public nuisance.
- 4. **Contrary to a Valid Zoning Ordinance:** The issuance of this license would be contrary to the provisions of the City of San Francisco's zoning ordinance. The property is in the WMUG (Western SoMa Mixed Use General) zone, which requires a Conditional Use authorization from the SF Planning Commission for this type of establishment, demonstrating it is not a permitted-by-right use.

I am a strong advocate for the growth of our neighborhood, including new housing and businesses that contribute positively to our community. It is precisely because I want SoMa to succeed as a dense, safe, and desirable place to live that I must object to this specific application.

Dear Sirs

I write to you concerning the application by RoyalMart aka Unimart, for a type 21, general liquor license, as I believe there is an upcoming Supervisor's hearing on it.

I think this license is a bad idea and have filed opposition with the ABC (attached).

In summary,

- (a) we have a significant problem with loitering and public drinking at this corner already, with consequent public urination.
- (b) The Unimart aims to attract those looking for cheap alcohol they have a sign outside advertising "bargain WINE & BEER market" already. They also do not manage their sidewalk, often having drinkers and other loiterers outside the store, with consequent significant litter problems. They have made little attempt to be good neighbors; there have been many police calls.
- (c) this is an unsuitable location even for a well-managed store. It is opposite a long-established shelter (the Sanctuary) who often have people who are trying to maintain sobriety. There are other centers in the immediate neighborhood, including new sober youth housing.

Given this, I question whether they should retain their 20 beer and wine license; they surely should not have spirits.

First, this corner already attracts loitering and public drinking and drug use at the adjacent bus stop, and, until recently, people sitting and drinking at the Royal Mart loading dock. The loading dock was recently closed off, which is an improvement, but the underlying problem remains. Drunkenness on the "public sidewalk abutting a licensed premises" constitutes a nuisance (B&P Code 24200), and exacerbates the public urination problem at the telephone pole at the adjacent corner of Tehama Street. We already have a significant problem with discarded beer and wine containers, and plastic and single-use spirits bottles from other outlets, in this area. We do not need more.

Second, this facility attracts problems, more than it deals with them. It already has a banner advertisement outside reading "bargain WINE & BEER market". Only after many months of the problems described above, resulting in many police calls, did the loading dock get closed, around the time the application for a spirits license was filed.

Third, this is an unsuitable location for liquor sales. It is closer than 600 feet to a non-profit facility (B&P Code 24200) which houses people struggling with alcohol addiction: the Episcopal Sanctuary, which has been opposite the Royal Mart location since the 1980s. I have been asked by a resident of the Sanctuary to help address public drinking in this area, as it is a problem for him and others trying to maintain sobriety. It is also too close to other service facilities: the drug treatment facility on Howard, the dense network of supportive housing around this area, and the new youth housing on Folsom St. Its proximity to 6th Street (only two blocks away) is liable to worsen, and spread out, the issues on that street that the city is spending so much time and money to address.

In summary, this is not a suitable location for spirits sales, and the 21-Off-Sale General License should not be granted.
