

The applicant submitted the application for a Type 21 Off-Sale General liquor license to the California Department of Alcoholic Beverage Control on August 15, 2025. The application is currently pending under license no. 21-671556.

7. When and how the applicant completed the noticing requirements for the liquor license, pursuant to state law.

The applicant mailed notices to all residents within a 500-foot radius of the premises on September 22, 2025 and posted the poster on the premises on September 9, 2025.

8. An explanation for how the license will serve the public convenience or necessity in the neighborhood and city-wide.

- A. Providing spirits to the customers who already frequent the location (since the location already sells beer & wine, the transfer will allow the existing location customers to complete all alcohol purchases in one location, rather than going to another store for spirits.
- B. There are no other convenient stores that sell full spirits on that block of Haight Street, so it will be more convenient for the public.
- C. There are only 3 other comparable off-sale liquor stores on Haight Street (1754 Haight St, 1589 Haight St, 1699 Haight Street, none of which will include the unique selection of products (including the unique deli items) offered by Applicant.
- D. fAmal's Market is conveniently located within walking distance for many local residents and provides improved access to a wider variety of groceries, household goods, and deli food, as well as responsibly sold alcoholic beverages, in a convenient neighborhood location.
