2 CREATING UNDERGROUND DISTRICT NO. 349 ON 24TH STREET FROM SOUTH VAN
3 NESS AVENUE TO CHURCH STREET.

5 NOTE: This entire Section is new.

7 Be it ordained by the people of the City and County of San Francisco:

8
9 Section 1. In accordance with the provisions of Section 901, et seq. of Article 18,
10 Chapter X, Part II of the San Francisco Municipal Code (Public Works Code), the Board of
11 Supervisors does hereby create the following underground district:

12 Underground District No. 349

13 (Mid-24th Street District)

14 covering 24th Street from South Van Ness Avenue to Church Street.

15 Section 2. The undergrounding of facilities within this underground district is in the
16 general public interest in that said action will eliminate a heavy concentration of overhead wires
17 on a street that is extensively used by the general public and carries a heavy volume of pedestrian
18 and vehicular traffic.

1 Section 3. All work in connection with the undergrounding of facilities lying within this
2 underground district and subject to the laws with reference to underground districts is to be
3 completed in accordance with the Department of Public Works' program; provided, however,
4 that said work shall be commenced at such time or according to such priority as the Department
5 of Public Works has established.

6 Section 4. The Board hereby requests that the utility companies providing the
7 undergrounding of facilities within this underground district pay for up to 100 feet of each
8 underground service lateral occasioned by the undergrounding.
