

1 [Award of Professional Services Agreement - Jacobs Engineering Group, Inc - Waterfront  
2 Resilience Program – Not to Exceed \$40,000,000]

3 **Resolution approving the Award of Professional Services Agreement for program**  
4 **advisory services related to the Waterfront Resilience Program between Jacobs**  
5 **Engineering Group Inc., and the City and County of San Francisco, acting by and**  
6 **through its Port Commission, in an amount not to exceed \$40,000,000 for a term of five**  
7 **years, commencing on March 2, 2026, through March 1, 2031, with a single option to**  
8 **extend for five additional years, exercisable at the sole discretion of the Port**  
9 **Commission, pursuant to Charter, Section 9.118(b).**

11 WHEREAS, The Port manages the San Francisco Waterfront within its jurisdictional  
12 boundaries as the gateway to a world-class city, and advances environmentally and financially  
13 sustainable maritime, recreational and economic opportunities to serve the City of San  
14 Francisco, the San Francisco Bay Area, and the State of California; and

15 WHEREAS, The San Francisco Seawall was constructed more than a century ago and  
16 serves as the foundation for more than three miles of San Francisco waterfront, supporting  
17 historic piers, wharves, and buildings including the Ferry Building, and underpinning the  
18 Embarcadero Promenade which welcomes millions of people each year, serves as a critical  
19 emergency response and recovery area, and supports BART, Muni and ferry transportation  
20 and utility networks; and

21 WHEREAS, On August 8, 2017, the Port Commission authorized Port staff to award  
22 and execute a professional services contract with, CH2M HILL Engineers, Inc. to provide  
23 planning, engineering, environmental services, and communications (“PEC Contract”) for the  
24 Seawall Resiliency Project in the amount of \$36,349,740 and with a term of 10 years, with an  
25 option to extend the term for one additional year in the Port’s discretion, and authorized Port

1 staff to increase the contract amount, if needed for unanticipated contingencies, by an  
2 additional \$3,634,974, for a total contract authorization not to exceed \$39,984,714 (Port  
3 Commission Resolution No. 17-36); and

4 WHEREAS, On September 24, 2019, subject to the approval of the Board of  
5 Supervisors, the San Francisco Port Commission authorized Port staff to execute an  
6 amendment to the PEC Contract with CH2M HILL Engineers, Inc., for planning, engineering,  
7 and environmental services for the Waterfront Resilience Program, which includes the  
8 Embarcadero Seawall Program, the Flood Study, and related activities to increase the  
9 contract to an amount not to exceed to \$59,977,071 (Port Commission Resolution No. 19-41);  
10 and

11 WHEREAS, On October 7, 2025, the Port Commission authorized Port staff to execute  
12 an amendment to the PEC Contract with CH2M HILL Engineers, Inc., for planning,  
13 engineering, and environmental services for the Flood Study, and related activities to increase  
14 the contract to an amount not to exceed \$60,477,071 (Port Commission Resolution No. 25-  
15 68); and

16 WHEREAS, June 9, 2025, the Port issued a formal Request for Proposals (“RFP”) for  
17 Waterfront Resilience Program (“WRP”) Program Advisory Consultant, Sourcing Event  
18 0000010877; and

19 WHEREAS, The RFP sought a Proposer to enter into a program advisory services  
20 contract with an anticipated initial not to exceed amount of \$40,000,000 and an initial term of  
21 five years, with the ability to extend the term no more than an additional five years, and to  
22 increase the value proportionally based on actual contractual needs; and

23 WHEREAS, The Port received one proposal on August 1, 2025, that was responsive;  
24 and

1           WHEREAS, Port staff convened an evaluation panel to evaluate and score the  
2 proposal; and

3           WHEREAS, Port staff recommended awarding a contract to the sole and highest  
4 ranked Proposer, Jacobs Engineering Group, Inc.; and

5           WHEREAS, On December 9, 2025, pursuant to Resolution No. 25-85, the San  
6 Francisco Port Commission awarded the contract to the sole and highest ranked proposer  
7 Jacobs Engineering Group, Inc. for program advisory services related to the Waterfront  
8 Resilience Program in an amount not to exceed \$40,000,000 for a term of five years,  
9 commencing on March 2, 2026, through March 1, 2031, with a single option to extend for five  
10 additional years, exercisable at the sole discretion of the Port Commission; and

11           WHEREAS, Charter, Section 9.11 S(b), provides that the agreements entered into by a  
12 department, board or commission requiring anticipated expenditures by the City and County  
13 of ten million dollars, or a modification to such an agreement having an impact of more than  
14 \$500,000 shall be subject to approval by the Board of Supervisors by Resolution; now  
15 therefore, be it

16           RESOLVED, That the Board of Supervisors hereby approves the Award of a  
17 Professional Services Agreement for program advisory services related to the Waterfront  
18 Resilience Program between Jacobs Engineering Group Inc., and the City and County of San  
19 Francisco, acting by and through its Port Commission, in an amount not to exceed  
20 \$40,000,000 for a term of five years, commencing on March 2, 2026, through March 1, 2031,  
21 with a single option to extend for five additional years, exercisable at the sole discretion of the  
22 Port Commission, pursuant to Charter, Section 9.118(b).; and, be it

23           FURTHER RESOLVED, That within thirty (30) days of the Grant Agreement being fully  
24 executed by all parties, the Port shall provide a copy of the final agreement to the Clerk of the  
25 Board for inclusion into the official file.
