14 WHEREAS, A variety of departments within the City and County of San Francisco are  
15 still in the process of obtaining reimbursement for these disasters; and,

16 WHEREAS, The City and County of San Francisco recently changed the name of the  
17 department receiving these reimbursements to the Department of Emergency Management;

19 WHEREAS, The State of California requires that applicant's agents be named in the  
20 resolution, now, therefore, be it

21 **RESOLVED, That the Board of Supervisors of the City and County of San Francisco, a**  
22 **public entity established under the laws of the State of California, amend all prior Public**


