3 **Resolution enacting and rescinding traffic regulations on various streets.**

5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code  
6 and the San Francisco Traffic Code, the following regulations governing the movement of  
7 vehicles are hereby enacted or rescinded as designated below:

8 **RIGHT LANE MUST TURN RIGHT EXCEPT MUNI - ESTABLISH**

9 Howard Street, eastbound, approaching Spear Street.

10 **BICYCLE LANE - ESTABLISH**

11 Howard Street, westbound, from the Embarcadero to Fremont Street

12 **BICYCLE LANE - ESTABLISH**

13 Northbound Potrero Avenue at the Cesar Chavez Interchange, from the 101  
14 southbound off-ramp to 190 feet southerly.

15 **MULTIPLE LEFT TURN LANES - RESCIND**

16 Fell Street, westbound, at Octavia Boulevard.

17 **LEFT LANE MUST TURN LEFT - RESCIND**

18 Fell Street, westbound, at Octavia Boulevard.

19 **RIGHT LANE MUST TURN RIGHT EXCEPT MUNI - RESCIND**

20 Van Ness Avenue southbound, at Bay Street

21  
22 Categorically exempt from Environmental  
23 Review Class 1(c)(9) changes in the traffic and  
24 parking regulations where such changes do not  
25 establish a higher speed limit or result in more  
than a negligible increase in the use of the  
street.




